We went over the different bylaws and the importance of keeping detailed minutes of what is said and voted on and who is there.

The final recommendation for committee by laws will be Sept. 10, 09. The planning Dept. wants our opinions by the Sept. 10, 09 planning meeting and standing rules by October. Sherrie made a motion to table the standing rules until our next meeting, Bonnie seconded the motion, Steve-yes, Rachel- yes and Carla- yes, motion passed.

K & H Communities - Craig said that the planning dept. had not gotten any response from KH Communities about moving on with Madison/505 project. There are no plans to proceed before the General Plan is adopted. If, and when, KH Communities wants to move forward with an application they will have to conform to the new General Plan.

Alleyways were discussed and it's still not clear what the right of way or ownership is for some. The county does not maintain the alleys and some have no access. They have to be abandoned by the county and property owners all need to agree. We need to research more and find out who is responsible for the alleys and how to move forward from here.

Commissioner Keith Williams brought up The Esparto Advisory committee, they meet next on Aug. 18, 09, at 7:00 pm in the Esparto Library. They would like someone from MAC to attend if possible.

They have it on their agenda to discuss a combined Citizen Advisory Committee with Esparto, Madison and Capay.

Cal Trans project update from June 8, 09 meeting in Esparto. Sherrie attended and spoke to several different Cal Trans representatives. According to them it could possibly help keep Madison from flooding. Leroy says there is a lawsuit pertaining to the EIR and the project is on hold.

**Madison park update**: Leo has the areas for concrete dug out but not formed yet. He will need some volunteer help when he is ready to do the concrete and assemble the tables and benches. Don Rust said his son is a Boy Scout, in Loma Rica he and his scout friends need a project. Sherrie volunteered to talk to Leo about it.

Dear committee, board, or district member,

As a reminder, if you were appointed to your position by the Yolo County Board of Supervisors, you must receive ethics training every two years. If you have completed this training within the past two years, you don't need to complete it, until two years have elapsed.

If you need to take the training, you may attend a qualified facilitated session or complete the training online specified for members of local government boards and commissions.
