Senate Bill 676 County Fees

Bill Summary

SB 676 gives counties the authority to adjust several existing fees to levels that cover their costs of providing the service. It retains all existing requirements that a fee not exceed the cost of the service and ability-to-pay provisions.

Background and Analysis

Government Code §54986 describes the procedures that counties must follow to change fees otherwise authorized by law. If state law does not prescribe an amount or otherwise limit a fee, GC §54985 allows a board of supervisors to "increase or decrease a fee or charge... in the amount reasonably necessary to recover the cost" of providing a good or service or enforcing a regulation. GC §54985 also excludes a large number of fees from this provision. These fees are set by the state and include, among others, civil fees, county recorder fees and all fees charged by agricultural commissioners.

The fees set by state law, including vital records fees, recording fees and civil fees charged by the Sheriff's Department, appear to be the most inflexible and costly for counties. Many county fees set by the state do not cover the cost of providing the service. The process to increase these fees is cumbersome and the Legislature does not regularly review these fees to address changes in cost. Some fees have not been updated in 20 - 30 years.

When a fee based service does not recover sufficient funds to cover the cost of providing the service, the difference comes out of the county's general fund. The cost of these services is supposed to be borne by only those using the services, but ends up being subsidized by all taxpayers – including those who never use a particular service. This in turn puts pressure on other services that are funded by the county general fund, such as indigent health care, libraries, and law enforcement.

Specifically, SB 676 allows counties to make adjustments to the following fees:
