**WHEREAS,** in 1975 Ms. Kemper served as an Intern to Lt. Governor Mervyn Dymally's Education Advisor Joe Serna and followed that experience with an internship as a Management Trainee for Sacramento LAFCO; and

**WHEREAS,** in 1978 Ms. Kemper began her Yolo LAFCO career as an analyst and served as the LAFCO Executive Officer for the last twenty-two years; and

**WHEREAS,** from 1979 through 2009, Elizabeth simultaneously served as a Principal Management Analyst in the Yolo County Administrator's Office; and

**WHEREAS,** during that time Elizabeth worked with 23 members of the Board of Supervisors, 12 County Administrators, and provided valuable input on issues considered at over 700 Board meetings; and

**WHEREAS,** Elizabeth provided important knowledge, advice, and guidance to numerous elected officials, community and civic members, and County and LAFCO staff; and

**WHEREAS,** during her tenure with LAFCO, she has processed approximately 11 Formations, 40 Annexations, 72 Reorganizations, and the incorporation of the City of West Sacramento; and

**WHEREAS**, Elizabeth also prepared municipal service review and sphere of influence studies for the four cities and 54 special districts in Yolo County; and

**WHEREAS,** Elizabeth also helped develop important and innovative agricultural preservation initiatives, including the Yolo LAFCO Agricultural Conservation Policy and the LAFCO Land Evaluation and Site Assessment (LESA) Model; and

**WHEREAS**, Elizabeth served as the California Association of LAFCOs' Executive Officer from 1991-1994 and provided expert support for various CALAFCO legislative, administrative, and executive committees at different times throughout her LAFCO career; and

**WHEREAS,** Elizabeth has been integral in the effectiveness of this LAFCO, which received the 2000 CALAFCO Most Effective Commission Award for its innovation and initiative in implementing LAFCO programs; and

**WHEREAS,** in 2005 Elizabeth received the CALAFCO Distinguished Service Award for her long and renowned service; and

**WHEREAS,** in 2005, Elizabeth also received the Sacramento Area Council of Governments (SACOG) Salutes Special Recognition Award for helping to create viable, living communities that adhere to the principles of smart growth; and

WHEREAS, Elizabeth is devoted to her husband of 28 years and her children, Samantha and Randall; and

**WHEREAS,** Elizabeth will continue to use her extensive knowledge, wisdom, and experience to mentor her staff.
