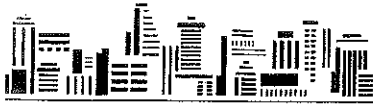

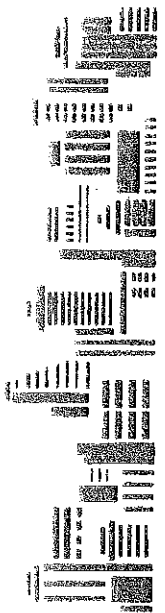
Dear Lisa:
