8. 7:30 Public Meeting on the proposed Granite Esparto Mining Project Draft environmental impact report (EIR). Report by staff (Heidi Tschudin) and receive comments from the committee and members of the public.

The project site is adjoining County Road 87, approximately one mile north of the town of Esparto. The site is two adjacent parcels, APN 048-220-151 (286.4 acres) on the north side of Cache Creek, and APN 048-220-221 (103.6 acres) on the south side. Mining is proposed on 313 acres of the 390-acre total. The project proposes the mining of about 30 million tons (26.1 million tons sold maximum) of aggregate over a 30-year period at a rate of about one million tons per year (870,000 tons sold maximum).
