Subject: Board of Supervisors Key Accomplishments – 2009

I take this opportunity to highlight a few of our significant achievements in 2009, and to acknowledge my colleagues on the Board of Supervisors, the Clerk of the Board and staff, the Supervisor's Deputies and Assistant Supervisor's Deputies, the County Administrator (past and interim) and staff, the County Counsel and staff, department heads, and each and every Yolo County employee who contributed to all our many achievements in 2009.

Despite the downtown in the economy, and difficult decisions that had to be made in 2009, we have many accomplishments in 2009 for which to be proud. Each achievement furthers our vision for Yolo County in 2022:

Yolo County 2022 has preserved agriculture and used open space and natural areas to separate our distinctive communities.

Yolo County 2022 is a place for healthy living supported by easy mobility and a 21st century technology community.

Yolo County 2022 has a strong local economy and an abundance of water.

A great place to call home!

Our many accomplishments also further the Board of Supervisors' adopted goals for 2012:

- Financially sustainable county government
- Environmentally sensitive and quality county infrastructure, facilities and technology
- Top quality workforce providing responsive services
- Preservation of agriculture and open spaces with planned development
- Partnering for a successful Yolo County
- A safe and healthy community

Budget and Finance

- Devoted strategic planning efforts specifically to budget planning in preparation for a \$22 million shortfall in General Fund, which ultimately grew to \$25 million. Directed staff to build the 2009/10 budget based on:
 - o use of \$4.2 million in reserves;
 - o \$2 million new General Fund revenue; and
 - negotiations with labor representatives in an attempt to reach \$5 million in countywide savings from measures to reduce salary and benefit costs. Ultimately a savings greater than \$6 million was achieved as a result of employee concessions.
- Adopted initial county budget of \$330.6 million which included authorizing two-year service credit purchase contract provision for the early retirement of 114 employees and layoff of 30 employees, allocating 80% of the budget and setting aside the remaining 20% into contingency by department pending additional state cuts, and the following:
 - Approved allocation from Pomona funds for the following:
 - \$170,000 for the tobacco cessation program
 - \$100,000 for the syringe exchange program
 - \$175,000 for the Yolo County's Children's Health Initiative program
 - \$150,000 for In-Home Supportive Services Public Authority's budget, subject to further review and appropriation
 - Approved allocation from the General Fund for the following:
 - \$59,000 to restore the veterans service representative position
 - \$232,000 to restore two child welfare positions
 - Approved allocation of \$153,000 from the Alcohol, Drug & Mental Health General Fund (loan payment) and \$405,000 from Pomona funds into a contingency for the indigent health program, subject to further Board review and appropriation
 - Approved ending state and federal lobbyist contracts
- Returned in September to adopt final county budget of \$338.2 million amended with additional revenue (primarily American Recovery & Reinvestment Act funds) and state cuts.
- ARRA (American Recovery & Reinvestment Act) funding received to date.

General Government

- Approved economic stimulus infrastructure priorities.
- Approved appropriation of \$30,000 from the development impact fee fund for Yolo County's share of the Woodland-Davis Alternative Transportation Corridor (ATC) feasibility study.
- Approved designation of the UC Davis Fire Department as a Yolo County Safe Haven for the surrender of newborns.
- Approved recommended actions in the Draft Comprehensive Economic Development Strategy (CEDS).
- Revoked reentry facility siting agreement with the California Department of Corrections and rehabilitation.
- Received public comment on Clarksburg wine industry and tourism feasibility analysis and accepted final product for submittal to the California Department of Housing and Community Development.
- Appointed Robyn Truitt Drivon as Interim County Administrator and proceeded with open search for a County Administrator.
- Considered proposed wetland habitat creation, restoration and enhancement ordinance and other
 potential means of authorizing limited county regulation of wetland habitat projects, mitigation
 banking and similar conservation actions.
- Continued efforts to protect the county's interests related to the expansion of the Cache Creek Casino Resort. The Yocha Dehe Wintun Nation ultimately decided not to proceed with the proposed version of the expansion.

- Approved use of \$5,585,000 Recovery Zone Facility Bond allocation for a new Comfort Suites in Woodland and an expansion of two Davis Flight Support private projects to create new investment and jobs.
- Adopted resolution supporting California Forward 2010 Reform Plan.
- Appointed Patrick S. Blacklock as County Administrator.
- Approved Yolo County Economic Development Strategy.

Law & Justice Services

- Approved agreement with City of Woodland for Probation Work Program to provide basic yard work services for the city through June 30, 2011 – projected annual revenue of \$38,000.
- Approved agreement with Tuolome County to increase the rate per leased bed space at the Juvenile Detention Facility annual projected revenue of \$200,750.
- Appointed Tracie Olson as Public Defender.
- Appointed Marjorie Rist as Chief Probation Officer

Grants and awards received of note:

- \$16,996 from the California Department of Insurance to fund the cost of outreach to the citizenry of Yolo County and the investigation and prosecution of life and annuity financial abuse.
- \$322,264 from the California Department of Boating & Waterways for the Sheriff's Department's Boat Patrol, Boat Safety, and Search and Rescue programs.

- Declared the existence of a local emergency due to the global outbreak of Novel H1N1 Influenza.
- Held a Beilenson Hearing and approved the following actions regarding the Yolo County Healthcare for Indigents Program (YCHIP):
 - o Eliminate as covered services Medi-Cal optional benefits
 - Modify eligibility requirement to cover only documented residents of Yolo County and implement a share of cost of \$1.00 for each \$1.00 exceeding the Medi-Cal minimum need level (subsistence) based on the family size of YCHIP membership.
 - o Limit the specialty provider reimbursement to 100% of the current Medi-Cal fee schedule.
- Adopted Yolo Ag/Tourism Food Facility policy for agricultural homestays and bed & breakfast inns.

Planning & Public Works

- Adopted resolution terminating county maintenance on certain county roads.
- Adopted Yolo County Inclusionary Housing in-lieu fees and modified related provisions of the inclusionary housing ordinance programs.
- Responded to Transmission Agency of Northern California's (TANC) proposed transmission project, including adopting an ordinance to protect the county's interests. The project was ultimately pulled by the agency.
- Approved comment letter on Liberty Island Conservation Bank initial study/mitigated negative declaration.
- Adopted plans for replacement of the County Road 57 bridge over Cache Creek in Guinda.
- Adopted plans for the second phase of the Davis-Woodland Bikeway project.
- Adopted plans for County Road 22 rehabilitation project.
- Adopted Alcoholic Beverage Control ordinance to place new permitting requirement on the sale of alcohol within the unincorporated area.
- Adopted collaborative planning principles with the City of Woodland.
