# Entry No. 9 Opened the Public Hearing, adopted the Mitigated Negative Declaration of Environmental Impact and approved the Castle Commercial Annexation to the Esparto Community Services District

**Minute Order 2007-21**: After a report by staff the Chair opened the public hearing. After public comments the Public Hearing was closed.

After discussion by the Commission a motion was made for the following recommendations:

- The Commission asked staff to further amend number 14 of the Findings and Conclusions of the Executive Officer's report, which states that "[t]he proposal site includes 2 acres of undeveloped Class II soil , which are not feasible to irrigate. (page 10); and
- That the Commission not require the condition for agricultural mitigation as described in section 4.(b) of the staff report, which states: the applicant shall mitigate the loss of 2.35 acres of prime agricultural land through the purchase and dedication of an agricultural conservation easement of the payment of an in-lieu fee (page 10); and
- 3. Support the balance of staff recommendations as presented.

The motion further accepted the Mitigated Negative Declaration of Environmental Impact as the appropriate environmental review and adopted **Resolution 2007-03** approving the Castle Commercial Annexation to the Esparto Community Services District.
