## <u>Item № 8</u> <u>Considered CALAFCO Request for Comments on Proposed CALAFCO Regions</u>

Anderson, suggesting that no changes be made to the structure of CALAFCO. Yolo LAFCO believes the existing CALAFCO representation structure is working well and that separate regions may not increase or improve communication opportunities. If representation on the CALAFCO Board of Directors is an issue, Yolo LAFCO prefers to address that matter directly and is in favor of discussing voting options that will provide southern California counties greater representation on the CALAFCO Board.

#### <u>Item № 9 Executive Officers Report</u>

A verbal report was given on potential LAFCO proposals and pending and active municipal service review and sphere of influence (MSR/SOI) studies.

Staff is working on the second round of MSR/SOI's. Active studies include the City of Woodland and the Wild Wings County Service Area MSR/SOI's. Proposed studies include the Esparto Community Services District and the west county special districts as a whole because of overlap of responsibilities. Due to the District's current financial constraints staff is looking at the possibility of having a more cooperative provision of services.

Potential proposals include the Knaggs Annexation to the City of Woodland at East Main Street and CR102, Woodland Gateway-Phase II South, UCD/West Village Annexation to the City of Davis, and the Springfield Ranch Annexation to the City of Winters.

#### Item № 10 Commissioners Report

Commissioner Woods made note that Commissioner Souza was successfully elected to the CALAFCO Board of Directors on October 29, 2009, at the CALAFCO annual conference, remarking that it has been at least 10 years since Yolo has had a representative on the CALAFCO Board. Commissioner Woods also commended Commission Counsel Robyn Drivon for her service to LAFCO and for attending the conference during her dual role as Interim County Administrator and County Counsel.

Commissioner Souza suggested we need to have representation of all of our Yolo County wines on display at the next conference during the wine tasting reception.

Executive Officer Elizabeth Kemper remarked that the conference went well. There were very good sessions, including one about water. Commissioners Ramming and Thomson made themselves well known at the Commissioners roundtable by supporting the Yolo LAFCO agricultural policy.
