Debra LaVio has already told me we will not receive any money to do this project. You all will have to do this all on your own. Its going to be an independent charter school, with the parents putting in 30 hours a year for help. We have an open house March 20th and 21st from 1:00 to 3:00p.m. It will be a k-6 Science and Technology Academy with Math Immersion and English. We will be seeking the authority and we will be running it. There will be a Governings Board, no principal, no busing, no money cost. And there are no longer any district transfers to Robbins. They are no longer accepting them. Mrs Edson Askes will there be any Breakfast or lunch for these children? Maria Martinez I don't know.
