Received comments from the Executive Director, Lisa Baker, who addressed the Board of Commissioners and provided an update on the following issues:

ACCOMPLISHMENTS – April 2010

Operations

- Voucher program scored a perfect 100% in the federal PIC system almost impossible to do. 100% matching records, 0 late re-examinations and 0 late HQs inspections. 95% is the threshold and 98% is a good performer.
- Also in Vouchers, we have called 50 households off the wait list the first time we have been able to call families since 2008. 28 households have responded to date. Staff is reviewing information at this time.
- In Vouchers, six families have ported in from other jurisdictions and some of our families will be leaving. We are currently absorbing families into our program.
- In Real Estate Services, we continue to be between 98% and 99% leased and staff is doing a good job of unit turnover.

Facilities

- We completed the ARRA window replacement project with both West Sacramento Senior complexes on 5/13/2010. The contractor is moving now to Yolo, Knights Landing and Esparto next
- The Davis Solar homes window replacement project will be completed by Ma 31, 2010.
- The RFP for pest control services is complete and will be advertised later this month.
- There is a bid out now for a maintenance truck replacement with the bid closing on May 18th. Funding comes from the 2008 Capital Fund.
- Non-operable serviced out vehicles (6) are being removed from inventory this week.
- The bid walk for the 2008 Capital Fund at Riverbend Senior Manors is slated for Monday, May 17, 2010.
- The back up generators for the water system and office are being set this week. They are expected to be fully operational b the end of May.

Administration

• YCH has added another free wireless "hot spot" at West Sacramento. Some of the youth have already reported that they are happy to use the service with their own laptops at the computer center. YCH currently has 2 hot spots (main admin and West Sacramento).

- We have replaced the Tenmast server with a new, bigger and much faster server.
- The ED attended the Pacific Southwest conference of the National Association of housing and Redevelopment Officials (NAHRO) and spoke on water issues in the Pacific Southwest.
- Janis Holt attended the Housing Authority Human Resources Consortium conference in April learning valuable information on Section 3, Pre-Employment/Post Offer Physicals, Conflict Resolution, Employment Law Update, Confidentiality, and Cal-OSHA Loss Control. In addition, the consortium is working on an updated survey of salary and benefit information relevant to PHA's across the state.
- Presented an overview of the YCH Section 3 Plan at the PSWRC NAHRO Conference in May. The feedback was positive and the recently adopted Section 3 Plan has been shared with several PHA's in California and was recently requested b Omaha, Nebraska.

Education

- Marianne, Brenda and Cindy from Housing Services/Real Estate Services attended USDA training and received their Certificates in Farm Labor programs.
- April 22, Legal Services of Northern California provided the annual Fair Housing Training to over 100 landlord participants at YCH. The response was "standing room only!" Presentations were made by Anita Joseph, District Administrator, California DEFH, Meliah Schultzman, Staff Attorney, National Housing Law Project, and Alysa Meyer, LSNC.
- ERMA (Employment Risk Management Association) will be providing management training (including AB1825) to management staff on Tuesday, May 18, 2010.

<u>Staffing</u>

• We have two (2) new tenant liaison volunteers starting in June for the Woodland and Winters sites.

<u>Services</u>

- "Save the Date" flyers for the YCH Partner Appreciation and Open House Event were emailed to over 300 community partners and 100 colleagues. WE have already received almost 30 confirmed responses so far.
- YCH had a nice surprise at the California Housing Workers Compensation Association (CHWCA) Annual Board Meeting held April 22 that they will receive a dividend check in the amount of \$47,383 at the end of May.
- Resident meeting at the Riverbend Senior Manor where Monaghan Architects discussed the proposed rehabilitation project. Over 30 residents attended, including approximately 8

Russian speaking residents for whom translation services were provided by our own Yuriy Sheyko (Sr. Maintenance and certified translator/interpreter).

- Quarterly resident meetings are scheduled for the end of the month at three additional sites.
- For the past couple years YCH has participated on the Community Services Action Board which determines CSBG funding for Yolo County. The funding priorities have continued to be emergency shelter and food programs. The state has some discretionary funding that Yolo County will be applying for on a competitive basis, \$100,000 for bulk food purchase, specifically meat, in partnership with the Yolo County Food Bank.

Received comments from the Board of Commissioners. Commissioner Provenza thanked the Executive Director for her help and responsiveness in getting a constituent housing. Commissioner Thomson spoke of the kickoff for the 10 year plan to end Homelessness and thanked Lisa and her staff for her contributions to that effort, as well.
