4.1 Annual Site Inspection (Creek Walk)

**PLEASE NOTE**, In order to thoroughly document the changing conditions of Cache Creek, the Technical Advisory Committee will be conducting portions of the annual inspection on foot. To facilitate the inspection of specific sites, walking over uneven terrain and through dense brush within the channel may be required. Therefore, participants should bring clothing appropriate for the terrain and weather conditions and personal items such as sun block, sunglasses, food, water, toiletries, and any other items appropriate for the natural elements and terrain. Participants should be aware that they could encounter rattlesnakes, bees, mountain lions, and other potentially hostile wildlife. Public restrooms will not be available. Participants will use private vehicles on public and/or unpaved private roads to begin and end the trip. Carpooling is encouraged.

4.2 CEMEX Madison Aggregate Mining Facility -- Amendment of Flood Hazard Development Permit #2008-\_\_\_ identifying modified in-channel improvements to stabilize the creek, control erosion, and provide 100-year flood conveyance, and thereby remediate violations of SMARA and correct non-compliance with Long-Term Off-Channel Mining Permit No. ZF #95-093 and Development Agreement No. 96-287. (APNs # \_\_\_\_\_; south of Cache Creek, west of Interstate 505 near County Road 92C).
