AGREEMENT NO. 10-OMS-931 (RD) FOR DAVIS MIGRANT CENTER

### **RECOMMENDED ACTION:**

That the Board of Commissioners:

Adopt the Resolution Authorizing Adoption of Standard Agreement No.10-OMS-931 (RD) for the Davis Migrant Center located in the City of Davis.

### **BACKGROUND / DISCUSSION:**

YCH manages migrant centers for the Department of Housing and Community Development, Office of Migrant Services (OMS). These are funds for administering housing for migratory workers and their families at the Davis Migrant Center in the City of Davis. The contract amount for the FY 2010-2011 is \$454,658. Although the State has not yet provided the agreement for review, OMS has provided the approved budget and agreement number that will be assigned. We have been advised that the new agreement will have revised insurance requirements which will be reviewed upon receipt.

#### FISCAL IMPACT:

Failure to adopt this resolution will delay OMS contract payments. YCH has OMS approval to use restricted migrant rent collection cash to cover costs incurred prior to full contract execution so currently we do not have cash flow difficulties.

## **CONCLUSION:**

The Resolution is recommended for adoption.

# (Resolution Authorizing Adoption of Standard Agreement No.10-OMS-931 (RD) for the Davis Migrant Center)

WHEREAS, Standard Agreement No.10-OMS-931 (RD) ("Standard Agreement") with the California Department of Housing and Community Development ("HCD"), will provide contract budget funds for administering housing for migratory workers and their families at the Davis Migrant Center in the City of Davis, County of Yolo, State of California; and

WHEREAS, it is desirable and necessary that this Agreement be agreed upon between the HCD and the Housing Authority of the County of Yolo; and

WHEREAS, the term of the Standard Agreement is upon HCD approval through August 31, 2011.

NOW, THEREFORE, BE IT RESOLVED, ORDERED AND FOUND by the Board of Commissioners of the Housing Authority of the County of Yolo, as follows:

- 1. Each of the foregoing recitals is true and correct.
- 2. The attached Standard Agreement No.10-OMS-931 (RD) between the California Department of Housing and Community Development and the Housing Authority of the County of Yolo is hereby accepted and approved with a maximum amount of \$454,658.
- 3. The Executive Director on behalf of the Housing Authority of the County of Yolo is hereby authorized and directed to execute Standard Agreement No.10-OMS-931 (RD) and any other documents necessary for the implementation of Standard Agreement No.10-OMS-931 (RD).
- 4. The Executive Director on behalf of the Housing Authority of the County of Yolo is hereby authorized and directed to sign "subsequent amendments" or "amendments thereto," if amendments are necessary.

**EFFECTIVE DATES:** This Resolution shall take effect from and after the date of its adoption.
