Agenda Item No. 4.04 Executive Director Comments

Received comments from the Executive Director, Lisa Baker, who addressed the Board of Commissioners on the following issues:

 Provided update and photos on the West Sacramento River Bend Development and noted that the window project is complete and work on the façade and exterior is in progress. Nonskid service is completed on the sidewalks for safety reasons. They are planning a rededication ceremony in November and invitations will be forthcoming.

• Provided update on the second playground at Yolano/Donnelly, so now there will be two playgrounds, which will improve safety and security for younsters.

• Met with architect for roads proposals at the Winters Property. YCH was successful in regaining ownership of the roads at this property from the County, so now they are responsible to maintain and repair/replace as necessary, depending on funding.

• \$1.2 million in ARRA funds will be completely expended by the end of the month. Refrigerators and hot water heaters are due for installation in October/November.

• As the Chief Negotiator of Pacifica Project in Davis, the initial proposal to the City is coming to the Davis City Council on September 21st.

 All monthly required groundwater/wastewater sampling testing and reporting has been completed. It is estimated they save approximately \$20,000 a year in contract costs by having their own, trained Class 1 water operators perform these samplings.

 Hosted the Phoenix League Annual Statewide Tournament for soccer at the Davis Migrant Center and they also completed the YCH Soccer Tournament, with five teams competing. Madison was the winner this year. They plan to honor those folks who made the soccer league successful.
