Recommended Action

Continue the Public Hearing for the Yolo County Public Cemetery Special Districts (except for Davis) Draft Municipal Service Review and Sphere of Influence (MSR/SOI) Study and Categorical Exemption to the next regularly scheduled LAFCO meeting.

Reason for Recommended Action

The Cemetery Districts need additional time to review the study and to respond with any comments, suggestions, or changes, to the Draft MSR/SOI. Additionally, staff would like more time to evaluate the District's responses and consider the Commissions directive for a more in-depth look at the feasibility of consolidation of one or more of the Cemetery Districts.

Background

The Commission received the Yolo County Public Cemetery Special Districts Draft MSR/SOI on February 28, 2011 for review. The Commission approved the separation of the Davis Cemetery District portion from the Draft MSR/SOI so that staff could further study the District's request for potential expansion of its SOI.
