PUTAH CREEK MOSQUITO ABATEMENT

MCCAPES

A representative of the Sacramento-Yolo Mosquito & Vector Control District has been invited to brief us on the District's efforts to protect public health in Willowbank and along Putah Creek by managing immature and adult mosquitoes so they do not create a significant risk.

SACRAMENTO RIVER WATER PROJECT

COOLURIS

In September 2009, the Cities of Woodland and Davis established the Woodland-Davis Clean Water Agency (WDCWA), a joint powers authority, to implement and oversee a regional water supply project designed to replace existing groundwater supplies with surface water supplies from the Sacramento River. Once complete, the project will serve more than two-thirds of the urban population of Yolo County and UC Davis. In a series of meetings in the latter part of December 2010, the County Board of Supervisors, WDCWA and the Cities of Woodland and Davis approved a package of agreements with Conaway Ranch to purchase a water intake facility site on the Sacramento River, easements for project facilities, and permanent rights to 10,000 acre-feet of surface water annually, starting in 2016. The City of Davis through an agreement with the County supplies water to most Willowbank residents. Supervisor Provenza and Bob Clarke, Interim PW Director/City Engineer for the City of Davis will brief us on the project and its impacts on Willowbank residents.

CROWNCastle/NEW PATH DAS NETWORK PROPOSAL

KREITH

In 2009 NewPath sought to install a wireless communication antenna system in the City of Davis with a grid of 24 antennas to be constructed within the City limits. In December 2009 the City Manager rescinded the building and encroachment permits it previously issued and litigation between the City and NewPath followed shortly thereafter. NewPath has since been acquired by CrownCastle International. In November 2010 CrownCastle submitted a pre-application to the City that has become the subject of a series of public meetings. It is anticipated that CrownCastle will file a full application for the project as soon as next month. Some of the issues regarding the project include safety of the electromagnetic energy

to be emitted, the aesthetics and safety of antenna locations, who will use antennas and how antennas will effect our wired and wireless media and communications.

RESULTS RADIO, LLC

COOLURIS

Although the Yolo County Board of Supervisors approved the application for the construction and operation of a radio broadcast tower by Results Radio, LLC off Pole Line Road near the County landfill in September 2010, the FCC has yet to approve the license application for that location.
