#### **Item № 12 Executive Officer's Report**

The Commission was notified that staff and counsel would be attending the annual CALAFCO Staff Workshop and a CALAFCO University course on planning and land use laws April 5-8, 2011.

A verbal report was given on pending and active municipal service review and sphere of influence (MSR/SOI) studies and potential LAFCO proposals.

Active studies include the Wild Wings County Service Area. Staff is waiting for the County's response to questions from the Commission and ongoing concerns by the residents regarding services. Staff anticipates that the final draft MSR/SOI may be brought to the Commission on May 16, 2011.

Proposed studies include a Countywide, and regionally organized, fire protection district MSR/SOI and an overview of the west county special districts MSR/SOI, which will include the Esparto and Madison Community Services Districts and the Madison-Esparto Community Service Area.

Active proposals include the Dunnigan Incorporation. Staff is working with Commissioners Souza and Saylor on reviewing the proposals for the Comprehensive Fiscal Analysis (CFA) and, subsequently, choosing a consulting firm. Staff is anticipating the funds from the applicant to start the CFA. Staff will begin preparing a request for proposal (RFP) for the Environmental Impact Report (EIR) once outstanding deposits are received. The EIR is supposed to be prepared concurrently with the CFA.

Potential proposals include the Yolo County Flood Control and Water Conservation District (YCFCWCD) Reorganization, the Woodland Gateway Phase II Annexation to the City of Woodland, and the Knaggs Annexation to the City of Woodland.

#### Item № 13 Commissioners Report

Commissioner and CALAFCO Board Member Stephen Souza reported on the CALAFCO Legislative Committee meeting, which took place on Friday, March 25, 2011.

Chair Woods thanked Commissioners for his reappointment to the Commission and for approving the amendment to the Policy and Procedures for the

Appointment of Regular and Alternate Public Members.
