# Approve Selection of and Agreement with GST Consulting to Prepare the Comprehensive Fiscal Analysis for the Proposed Dunnigan Incorporation (LAFCO № 911)

After a report from staff and discussion by the Commission, applicant Mel Smith said he opposed the selection process of consultants for preparation of the Comprehensive Fiscal Analysis for the Proposed Dunnigan Incorporation and questioned the appropriateness of hiring the consultant that the LAFCO subcommittee recommended for the contract.

For the record, the Commission stated that the applicant for the proposed Dunnigan Incorporation owes an additional \$2,386 in LAFCO fees, \$8,000 in remaining deposit fees, and the full amount in consultant fees for the preparation of the Comprehensive Fiscal Analysis.

Received and Considered the Draft Public Cemetery Special Districts (except for Davis) MSR/SOI (LAFCO № S-036) Study, Held the Public Hearing, Accepted a General Exemption as the Appropriate Environmental Review, and Adopted the Draft Yolo County Public Cemetery Special Districts (except Davis) Municipal Service Review and Sphere of Influence as Final

After a report by staff and discussion by the Commission the Chair opened the Public Hearing. No one came forward and the Public Hearing was closed.

**Minute Order 2011-22**: Approved the recommended actions by accepting a General Exemption as the appropriate environmental review and adopting **Resolution 2011-03**, approving the Draft Yolo County Public Cemetery Special Districts (except for Davis) MSR/SOI as final, thereby:

- Maintaining the Capay, Cottonwood, Knights Landing, and Mary's Cemetery District's Sphere of Influence boundaries, which are coterminous with existing boundaries; and
- Adding a 20 year sphere of influence line to the Winters Cemetery District SOI to cause that portion of its eastern boundary at County Road 95 to square up with its northern boundary at County Road 27 forming a more logical and orderly boundary.

When staff returns with the Davis Cemetery District Sphere of Influence, discussion of consolidation will be included. Additionally, staff will periodically check in with the other five Cemetery Districts to encourage each District to follow the recommended actions of the Yolo LAFCO and the County Auditor-Controller.

### **Item № 11 Executive Officer's Report**

The Commission was notified that staff attended a CALAFCO University course on planning and land use laws and participated in the annual CALAFCO Staff Workshop April 5-8, 2011.

A verbal report was given on pending and active municipal service review and sphere of influence (MSR/SOI) studies and potential LAFCO proposals.

Active studies include a countywide, and regionally organized, fire protection district MSR/SOI and the Wild Wings County Service Area MSR/SOI.

Proposed studies include the west county special districts and the Cacheville Community Services District.

Potential proposals include the Yolo County Flood Control and Water Conservation District (YCFCWCD) Reorganization, the Woodland Gateway Phase II Annexation to the City of Woodland, and the Woodland Commerce Center (formerly Knaggs) Annexation to the City of Woodland. Staff received, and is preparing a response to, a Notice of Preparation for an Environmental Impact Report (EIR) for the Woodland Commerce Center Annexation.
