SUBJECT: Yolo County Bicycle Transportation Plan Update

The current Yolo County Bicycle Transportation Plan was adopted by the Board of Supervisors in December 2006, and is in need of an update to reflect changes due to the completion of projects over the past 5 years, and the adoption of the General Plan. The 2006 plan is available for review online at <http://www.yolocounty.org/Index.aspx?page=834>

A current plan is needed primarily to enable bicycle projects in the County to be eligible for State Bicycle Transportation Account funding. The Plan also facilitates the incorporation of County projects into the SACOG Bicycle Pedestrian Master Plan, as required to be eligible for SACOG controlled funds.

The Transportation Advisory Committee has historically provided the public forum for the development of the County's Bicycle Transportation Plan. The TAC meetings serve as a public venue to address public comment that may be received as the update is developed. Below is a tentative schedule for the process:

September 15, 2011 TAC meeting: Kickoff the update process.

October 5, 2011: Review the current Plan online, and provide comments by email to jim.campbell@yolocounty.org (or by phone at 666-8847) for preparation of first red-lined draft.

October 20, 2011 TAC meeting: Staff provides redlined draft for TAC review/discussion.

November 17, 2011 TAC meeting: Staff provides final draft for TAC review and approval to release for public comment/posting on County website.

November 17-December 31, 2011: Public comment period.

January 19, 2012 TAC meeting: Consider public comment and revised final draft prepared by staff.

March 2012: Recommend Board adoption.
