## City of Woodland Nondisposal Facility Element

California Public Resources Code (PRC), Section 41730 et seq., requires every California city and county to prepare and adopt a Nondisposal Facility Element (NDFE) for all new nondisposal facilities, and any expansions of existing nondisposal facilities, which will be needed to implement local Source Redcution and Recycling Elements (SRREs). A "nondisposal facility" is defined as any solid waste facility required to obtain a state solid waste facility permit, except a disposal facility or a transformation facility (PRC Section 40151).

The City of Wooldand has prepared, adopted, and hereby transmits to Yolo County the City's NDFE, as required by PRC Section 41730. The City is also submitting a copy of its NDFE to the California Integrated Waste Management Board (CIWMB) for review and approval. The City's NDFE will be appended to the City's SRRE at the time of the five year revision. A draft of this NDFE was submitted to the County's local task force, the Yolo County Waste Advisory Committee, for review and comment in accordance with the requirements of PRC Sections 41734 (a) and (b). As indicated by PRC Section 41735 (a), the adoption or amendment of this element is not subject to environmental review under the California Environmental Quality Act (CEQA).

## **Existing State-Permitted Facilities**

This NDFE acknowledges that there are no state-permitted nondisposal facilities within the City's jurisdiction.

Solid Waste: Currently, 100% of the City's solid waste is being taken to the Yolo County Central Landfill, located at County Rds. 28H and 104; this is a state-permitted disposal facility (Solid Waste Facility Permit number 57-AA-001).

Yard Material: Currently, green waste materials are going to Yolo County Central Landfill for use as alternative daily cover (ADC). This material is being processed by Valley By-Products, Inc., a company located at the Yolo County Central Landfill.

Valley By-Products, Inc. is currently permitted as a wood processing facility under the Yolo County Central Landfill state solid waste permit. This current permit allows for preparation of yard materials to be used as alternative daily cover at the Yolo County Central Landfill. Valley By-Products is now in the process of applying for a permit to include composting operations at this facility.

Recyclable Materials: Recyclable materials, including paper, glass, metals, corrugated cardboard, and plastics, which are being collected through City recycling programs are being processed by the Waste Management of Woodland sorting line. The facility is located in Woodland at 1324 Paddock Place. The cities of West Sacramento, Winters and Woodland participate in the use of the sorting line. Current facility capacity is 200 tons per month.

Inert Materials and Scrap Metals: The Yolo County Central Landfill permit allows for a scrap metal recovery area, concreate and asphalt reuse for roadbase, and a tire disposal collection area. These services are used by all the jurisdictions of Davis, West Sacramento, Winters, Woodland and unincorporated Yolo County.

## **Proposed Permitted Facilities**

The SRRE states that, "No new or expanded facilities are proposed within the jurisdiction of Woodland" (Woodland SRRE, p.9-6). However, there were several proposed facilities described in the City's SRRE which would be located outside the Woodland city limits.

Solid Waste: It is anticipated that the City will continue to send its solid waste to the Yolo County Central Landfill, which has ample capacity beyond the fifteen year planning horizon of the SRRE.

Yard Material: The City of Woodland SRRE states that the Valley By-Products facility (located at the Yolo County Central Landfill) "is proposed to expand to wood and green waste processing. The wood waste will be processed into fuel, mulch, and humus. The green waste will be processed into compost, possibly for use as alternative daily cover at the landfill". Valley By-Products is now in the process of applying for a permit to include composting operations at this facility. (Woodland SRRE, p.9-6).

Recyclable Materials: The City of Woodland SRRE included selection of an alternative during the medium-term planning period involving a materials recovery facility (MRF) to be located at the Yolo County Central Landfill. "The cities of Woodland, West Sacramento and Winters have agreed to commit their non-source separated commercial/industrial waste streams to the facility. Specific waste types to be targeted will be determined based on available markets, market specifications, and market availability." (Woodland SRRE, p-5-18). Waste Management of Woodland may, or may not, need to change it's facility to become permitted. Their long-range plans are not known.
