6.2 ZF# 2011-0064: Road abandonment request for an unmaintained portion of County Road 40 (Rayhouse Road). The applicant is proposing to assume private maintenance of the road, which is located entirely within their ownership. The section of road is located approximately 9 miles northwest of the community of Guinda, two miles east of Lake County and one mile north of Napa County (APNs: 018-310-001, 081-310-021, 018-330-020, 018-340-021, and 018-340-029), and is zoned A-P (Agricultural Preserve). A Statutory Exemption has been prepared. Owner/Applicant: Homestake Mining Co. (S. Cormier).

6.1 **ZF# 2011-0046**: Amendment to the Planned Development No. 51 (PD-51) overlay zone to allow the establishment of a Love's Travel Center. The facility would include 13,000 square feet of buildings, consisting of two fast-food restaurants, a market, a tire barn, and 24 fuel pumps. The site would operate 24-hours per day. Development would be served by an on-site domestic water system, waste water treatment pond, and storm water detention pond. The project is located at 28700 County Road 6, at the northwest corner of the interchange with Interstate 5, in the community of Dunnigan (APNs: 051-160-04 and -05), and is zoned C-H/PD-51 (Highway Commercial/Planned Development No. 51).
