- Roadtrip Wine Barn (ZF 2011-0057): Continue to review information provided by the County. This project is currently on hold by the applicant. The environmental analysis (Neg Dec) has not been completed.
- c. Wind energy off County Rd 85: Discuss current test of a proposed wind turbine site for 200 windmills. There are no pending applications for 200 wind turbines in this area. There is a recent application from Pioneer Green Energy for six new meteorological (test) towers. This met tower application will be subject to CEQA analysis after it has been deemed "complete," which has not yet occurred. The met tower application is within the comment area for the Dunnigan and Yolo-Zamora Citizens Advisory Committees.
