A verbal report was given on active municipal service review and sphere of influence (MSR/SOI) studies and potential LAFCO proposals.

Potential proposals include the Yolo County Flood Control and Water Conservation District (YCFCWCD) Reorganization and the Westucky Out-of-Agency Agreement with or Annexation to the City of Woodland.
