**NOTICE IS HEREBY GIVEN** that the Yolo County LAFCo has set Monday, July 26, 2012 at or after 9:00 a.m. as the date and time to hold a Public Hearing for the Final Yolo County Davis Public Cemetery Special District Municipal Service Review and Sphere of Influence Study in the Yolo County Board of Supervisors Chambers, 625 Court Street, Room 206, Woodland, California.

The hearing will be to receive testimony and consider action on the Final Municipal Service Review (MSR) and Sphere of Influence (SOI) for the Yolo County Davis Public Cemetery Special District. The MSR is a document used to review and analyze the services provided by the Cemetery District. The MSR is used to prepare and update the SOI. The SOI is a guidance document used by the Yolo LAFCo to help project the direction, type, and timing of boundary changes for the District. The project is exempt from the California Environmental Quality Act (CEQA) per CEQA Guideline Section 15061(b)(3).

The Final MSR and SOI documents will be available for review online and at the LAFCo office, 625 Court Street, Suite 203, Woodland, California, five days prior to the Hearing date. The Agenda will be posted at least five days prior to the noticed Hearing at the above address and online at [www.yololafco.org](http://www.yololafco.org). All interested parties are invited to attend the Public Hearing.
