Item № 10 Executive Officer's Report

The Commission was given a verbal report on recent events relevant to the Commission and an update of the staff's activities for the month, including the Shared Service Initiative.

The contract for West Sacramento Project Manager Katy Jacobson is on track and Ms. Jacobson will be introduced at the next LAFCo meeting July 26, 2012.

The animal services study on other fiscal models will be presented to the Yolo Managers on June 29, 2012. Additionally, an update was given to the Board of Supervisors at its last meeting regarding the timeline of the animal services process of the study.

The shared services ad hoc committee formed by the Commission has met twice to brain storm options and opportunities. Commissioners Davies and Saylor and staff will continue those discussions and formulate something to bring to the Commission soon.

Other opportunities for shared services are continuing to evolve. Staff has been included in meetings with the Yolo Managers group and several county-wide economic development group meetings.

There will be a Public Hearing for the Davis Cemetery District Municipal Service Review and Sphere of Influence Study (MSR/SOI) on July 26, 2012. The West Sacramento City Council met to discuss the Davis Cemetery District's potential expansion of its Sphere of Influence to include the City of West Sacramento. Additionally, the District Board received the draft MSR/SOI for review at its June 20, 2012 meeting.

On June 21, 2012, staff attended a planning committee meeting in Monterey for the CALAFCO fall conference. Staff submitted a proposal presentation for shared services and it was accepted to be included as a break-out session for the conference this year, which will be held at the Monterey Hyatt October 3-5.

Commissioner Davies commented that there is an apparent lack of awareness of the Shared Services Initiative among his council and fellow council members in the County. Commissioner Kristoff suggested that the city managers brief their councils. LAFCo staff agreed to bring this issue up at the next city managers meeting. Commissioner Woods asked staff for an update on efforts between the Davis Cemetery District and the Woodland Cemetery on potentially sharing services. Staff responded that it would be geographically impractical for the District to help the City with maintenance of the Cemetery; however, efforts are underway by the City staff to assist the Cemetery to financial solvency. Those efforts include potentially forming an advisory committee for the Cemetery and possibly sharing maintenance with the adjacent Saint Joseph Catholic Cemetery. LAFCo staff has also reached out to the local historical society foundation for possible fundraising efforts on behalf of the Woodland Cemetery. Additionally, staff may recommend that the City consider contracting with the District staff for its expertise on the marketing, branding, fees, and programs and outreach of its own cemetery.
