A. Boat Ramp Constrution; Jen Santos, Associate park Planner. Yolo County General Services Parks Division. Duane Chamberlains office called me and said I needed to be here to talk to you all About the boat ramp.

Jen Santos; there has been a lot of delays on this, it was supposed to be started this year but it's not going to happen. The original paperwork started in 2006. Jen Santos, yes we can I would also like to avoid all those phone calls. We will be giving notice for as far in advance as we now for sure. Ill be applying for a grant extension until 2015. So we will have till then to get it done.

Secretary; is this state or federal? Who's funding this project.

Jen Santos; This is funded by the state and boating waterways.

Secretary; How long will this project take to do?

Jen Santos; 4-6 months. There will a park host and new bathrooms. We will be informing people as much as possible when it will be open during construction and when it will be closing, the entire parking lot will be redone.
