Notice is hereby given that on **Monday December 3, 2012 at 3:30 pm**, or as soon thereafter as the matter may be heard, the Local Agency Formation Commission (LAFCo) will hold a Public Hearing at the Yolo County Board of Supervisors Chambers, 625 Court Street, Room 206, Woodland, CA to consider the following agenda item:

Project Title:

Yolo County Flood Control & Water Conservation District Reorganization (LAFCo № 914)

Project Description:

On July 9, 2012, the Yolo Local Agency Formation Commission (LAFCo) received an application from the Yolo County Flood Control & Water Conservation District (District) requesting annexation of 58 parcels (approximately 8,500 acres) into the District. The territory proposed for annexation is within the District's Sphere of Influence; however, some of the parcels will also require detachment from the Yolo-Zamora Water District. The subject parcels will remain in agricultural production notwithstanding the project.

The District has submitted documentation that 100% of the subject landowners consent to annexation. Therefore, it is the intent of the Commission to waive annexation protest proceedings at the December 3, 2012 public hearing. **Unless written opposition is received from affected landowners or registered voters regarding this proposal, or the Commission's intent to waive protest proceedings, there will be no subsequent protest and election proceedings.**

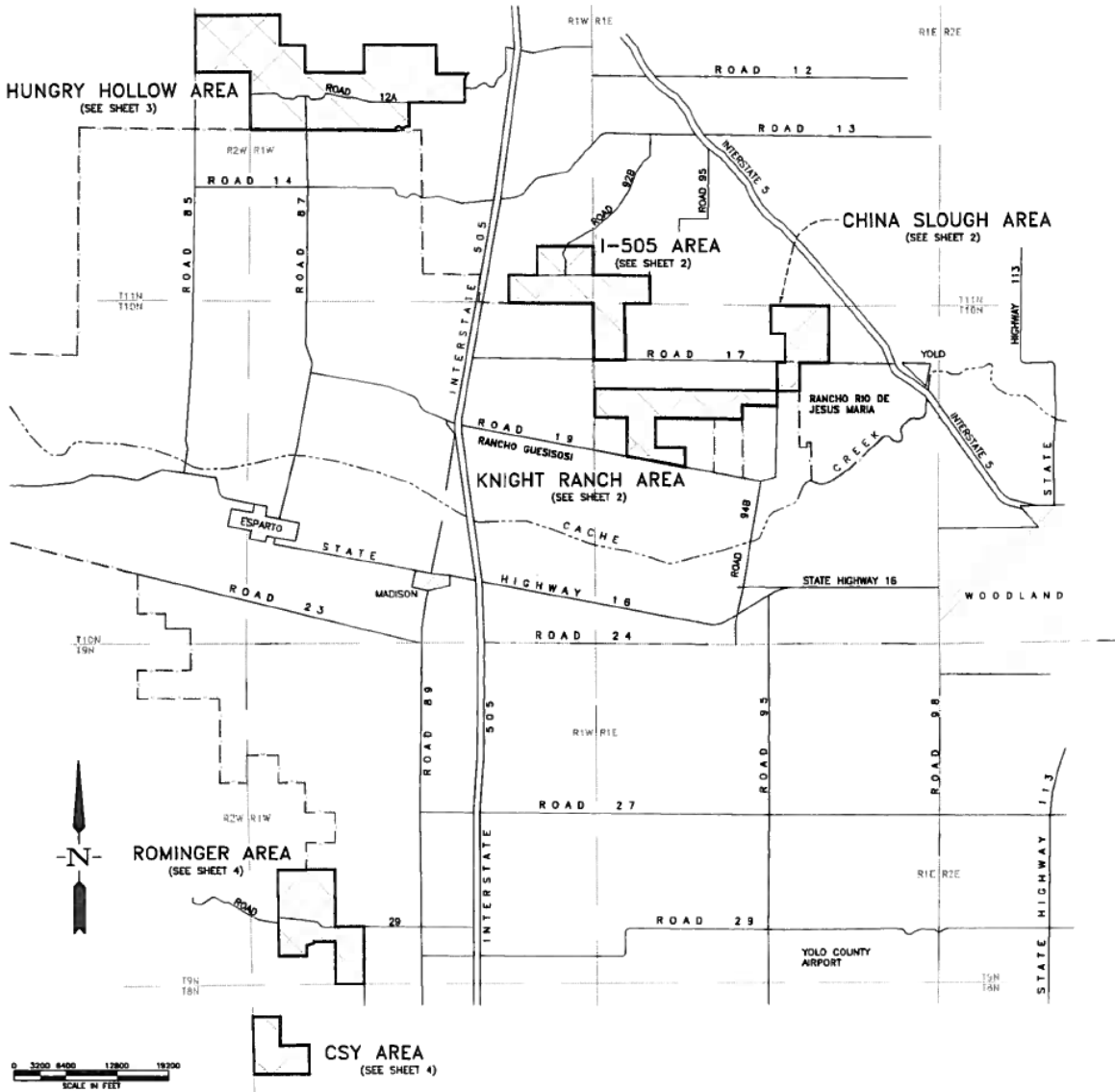

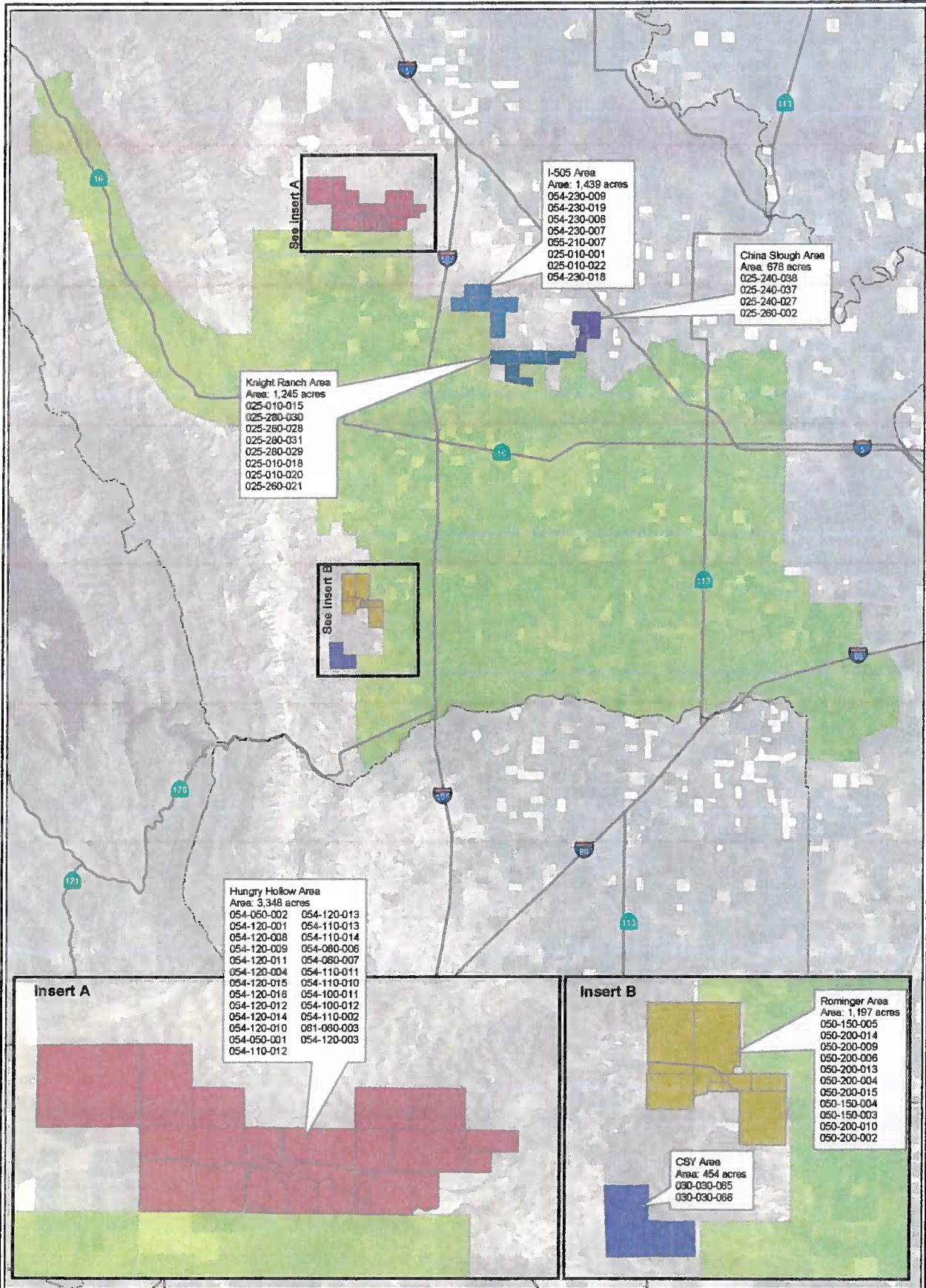

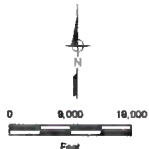
