Approval of Minutes of May 17, 2012, Meeting

The minutes of the May 17, 2012, meeting were unanimously approved with no corrections necessary..

Item 3. Public Works Update

Panos Kokkas provided an update on the Department's activities.

-CR 102, from the Davis city limits to CR 27, will be closed for resurfacing. Bids will be opened July 31, and work should begin mid-August.

-CR 98, from Main Street to the Woodland city limits will be closed for resurfacing. Scheduling will be dependent on work to be done by PG&E and

AT&T, to replace light poles and telephone lines, in advance of the project.

-CR 99, from the Woodland city limits north to I-5, will receive a new roadway by grinding the existing surface and mixing that with concrete, if funding is available. -CR32A, at the railroad crossing, will be upgraded using 1B and federal PUC funds. Guardrails and a rumblestrip will be installed. After bids are opened in late August and an award is made, a permit must be obtained from the railroad. Work should take place in mid- to late September and is expected to require 10 days,

including a 5-day road closure.

-A long-term project would provide new overlay from Mace Boulevard to the Vic Fazio Wildlife Area. This would require a shift of funds to be approved by the federal government, CALTRANS, and SACOG. Approximately \$700,000 is available, and a 20% match would be required. This may be a 2014-15 project.

-Construction has begun on the Salt Creek Bridge on CR29.

-Routine road maintenance and pothole repair have been ongoing.
