The Board of Supervisors of the County of Yolo, State of California, ordains as follows:

SECTION 1. Section 2-2.1808(b) of Article 18 of Chapter 2 of Title 2 of the Yolo County Code is amended to read as follows:

(b) The duties and responsibilities of the Waste Advisory Committee shall be as

Advise the County staff, the Board of Supervisors of the County, and the (1)staff, Mayors and Council Members of the Cities within the County on issues related to the development, approval, and administration of the County Hazardous Waste Management Plan.

Hold informal public meetings and workshops as required on the County (2)Hazardous Waste Management Plan.

Review issues of integrated waste management relative to the County (3) and provide recommendations to the County and Cities within the County on those issues.

Conduct hearings for those appealing decisions made under Article 6, (4) Chapter 15 of the Yolo County Code.

# **SECTION 2. EFFECTIVE DATE/ PUBLICATION**

This ordinance shall take effect and be in force thirty (30) days after its passage, and prior to the expiration of fifteen (15) days following its adoption, it shall be published once in The Daily Democrat, a newspaper of general circulation, printed and published in the County of Yolo.



AN ORDINANCE AMENDING CHAPTER 2 OF TITLE 2, ARTICLE 18, WASTE ADVISORY COMMITTEE, OF THE YOLO COUNTY CODE

The Board of Supervisors of the County of Yolo, State of California, DOES ORDAIN AS FOLLOWS:

9 **SECTION 1.** Article 18 of Chapter 2 of Title 2 of the 10 Yolo County Code is hereby amended in its entirety to read as 11 follows:

# <u>Sec. 2-2.1801. Created</u>.

Article 18.

# There is hereby created in the County a committee to be known as the Yolo County Waste Advisory Committee as required pursuant to Section 25135.2 of the Health and Safety Code.

17 The Waste Advisory Committee shall perform the duties of 18 the Local Task Force as required pursuant to Section 40950 of the 19 Public Resources Code.

### Sec. 2-2.1803. Membership.

The membership of the Waste Advisory Committee shall consist of eleven (11) rotating members who shall be selected as follows:

a) One (1) member from each city shall be appointed by
 the Cities of Davis, West Sacramento, Winters, and Woodland.

The Board of Supervisors shall appoint seven (7) 1 b) 2 members as follows: one (1) representative of industry, one (1)3 representative of environmental an organization, one (1)4 representative of a special district such as a fire protection 5 district or a community services district, one (1) representative 6 California - Davis, from the University of and three (3) 7 representatives of the public who, to the extent possible, have 8 expertise concerning aspects of integrated waste management <sup>...</sup>9 planning, including, but not limited to, engineering, geology, and 10 water quality.

#### Sec. 2-2.1804. Membership Terms.

a) The term of membership shall be four (4) years.

13 b) Notwithstanding the foregoing, the term of one (1) 14 City-appointed member shall expire each year, and the term of not 15 less than one (1), but not more than two (2) of the County-appointed 16 members shall expire each year. The Director of Public Works shall 17 develop a schedule to stagger the terms as set forth herein. The 18 Appointing Authority shall be advised of the expiration of a 19 member's term a minimum of two (2) months prior to the end of the 20 term.

21 c) Terms shall begin on February 1st and shall expire on
 22 January 31st.

## Sec. 2-2.1805. Membership Termination.

a) The Yolo County Waste Advisory Committee may
recommend termination of membership if in their opinion a member is
not adequately performing the duties for which the member was

appointed. The Appointing Authority shall terminate the membership of any person who in their opinion is not adequately performing the duties for which the member was appointed.

b) Resignations of members shall be accompanied by a letter or written documentation from the resigning member.

c) In the event of termination or resignation, the Appointing Authority shall appoint a new member for the duration of the unexpired term.

### Sec. 2-2.1806. Membership Organization.

10 a) The Waste Advisory Committee shall meet and elect a 11 chairperson and vice-chairperson annually at its last meeting prior 12 to February 1st. Such officers shall serve until their successors 13 are elected. The Director of Public Works or a designee of the 14 Director shall serve as staff liaison to the Committee and shall 15 provide secretarial services to the Committee. The County Health 16 Officer or a designee of the County Health Officer shall also serve 17 as staff liaison. The Board of Supervisors shall appoint one (1) 18 Board member to serve as its liaison to the Committee.

#### <u>Sec. 2-2.1807. Meetings.</u>

a) <u>Date</u>. Meetings of the Waste Advisory Committee shall
be held on a regular<sup>\*</sup> date set by the Committee. The Chairperson may
call special meetings as necessary.

b) <u>Quorum (Voting)</u>. A majority of all currently appointed members shall constitute a quorum of the Waste Advisory Committee. A majority of those present may take action on any matter presented to the Committee.

1 c) <u>Minutes</u>. The secretary of the Waste Advisory 2 Committee shall keep minutes of all specific actions taken and of 3 the recommendations made to the Board of Supervisors. The minutes 4 and member attendance shall be filed with the Clerk of the Board of 5 Supervisors, the Clerks of the City Councils, and with the City 6 Selection Committee.

101)Identify solid waste management issues of11countywide or regional concern.

2) Determine the need for solid waste collection and transfer systems, processing facilities and marketing strategies, that can serve more than one local jurisdiction within the region.

3) Facilitate the development of multijurisdictional arrangements for the marketing of recyclable materials.

4) To the extent possible, facilitate resolution of conflicts and inconsistencies between or among city and county source reduction and recycling elements.

5) Develop goals, policies and procedures which are consistent with guidelines and regulations adopted by the Board, to guide the development of the siting element of the countywide integrated waste management plan.

b) The duties and responsibilities of the Waste Advisory
 Committee shall be as follows:

1) Advise the County staff, the Board of Supervisors of the County, and the staff, Mayors and Council Members of the Cities within the County on issues related to the development, approval, and administration of the County Hazardous Waste Management Plan.

2) Hold informal public meetings and workshops as required on the County Hazardous Waste Management Plan.

3) Review issues of integrated waste management relative to the County and provide recommendations to the County and Cities within the County on those issues.

The Board of Supervisors shall appoint b) 1 seven (7) members including at least one (1) representative 2 of industry, one (1) representative of an environmental 3 organization, one (1) representative of a special district 4 such as a fire protection district or a community services 5 district, and four (4) representatives of the public who, to 6 the extent possible, have expertise and/or interest concerning 7 aspects of solid waste and hazardous waste management 8 planning, including, but not limited to, engineering, geology, 9 and water quality. 10 Sec. 2-2.1803. Membership Terms. 11 The term of membership shall be four (4) a) 12 years. 13 b) Notwithstanding the foregoing, of the 14 initial members serving terms of normal four-year duration, 15 one (1) appointed by the City Selection Committee and one (1) 16 appointed by the Board of Supervisors shall serve a term of 17 one (1) year, two (2) appointed by the City Selection 18 19 Committee and one (1) appointed by the Board of Supervisors shall serve a term of two (2) years, and one (1) appointed by 20 the City Selection Committee and two (2) appointed by the 21 22 Board of Supervisors shall serve a term of three (3) years. c) Terms shall begin on February 1st and shall expire on January 31st. The terms of the initial members shall be computed from the February 1st following appointment.

Sec. 2-2.1804. Membership: Termination.

a) The Board of Supervisors shall terminate the membership of any person who has three (3) consecutive unexcused absences from scheduled meetings or who, if appointed by the Board and in the opinion of the Board of Supervisors, is not adequately performing the duties for which the member was appointed.

b) Resignations of members shall be accompanied by a letter or written documentation from the member or the Waste Advisory Committee.

Sec. 2-2.1805. Membership: Organization.

The Waste Advisory Committee shall meet a) 16 and elect a chairperson and vice-chairperson annually at its 17 last meeting prior to February 1st. Such officers shall serve 18 until their successors are elected. The Director of Public 19 20 Works or his or her designee shall serve as staff liaison to the Committee and shall provide secretarial services to the 21 22 Committee. The County Health Officer or his or her designee shall also serve as staff liaison. The Board of Supervisors 23 24 shall appoint one Board member to serve as its liaison to the 25 Committee.
