## Project Description:

On January 7, 2013, the Yolo Local Agency Formation Commission (LAFCo) received an application from the Yolo County Davis Cemetery Special District (District) to expand its existing boundaries by annexing all the lands in its Sphere of Influence planning boundary. The existing cemetery in Davis has sufficient capacity to accommodate the new area and no new cemetery sites are proposed. By enlarging the District's boundary line, residents in the newly annexed area would have a public cemetery option for burial services. The District is not seeking any property tax revenue for this subject territory. Cemetery burial costs would instead be handled by the District instituting a two-tiered fee system correlating to the tax rate area zone of benefit.


