 - (1) Petroleum contamination from underground tanks
 - (2) Building contamination (lead based paint)
 - ii) They are now applying for 3 grants from US EPA. They tried last year but didn't quite make it.
 - iii) Once we can get the site cleaned up, then we can see what the community wants there. Aiming for mixed use: First floor commercial, second floor and behind residential. Trying to meet the needs of Streetscape and brick architecture that would blend in with the town.
 - iv) Community meetings to address methods of clean up.
 - v) Timeline:
 - (1) Deadline extended to 12/3 due to Hurricane Sandy.
 - (2) Should hear back in late Spring.
 - (3) Money may come in Summer or by 10/1.
 - (4) Multi-year process. Removal action plan pull material out and dispose at local landfill, backfill, then it will be ready for development.
