# NOTICE OF PROTEST HEARING LOCAL AGENCY FORMATION COMMISSION OF YOLO COUNTY

NOTICE IS HEREBY GIVEN that on **Thursday April 25, 2013 at 9:00 am**, or as soon thereafter as the matter may be heard, the Local Agency Formation Commission of Yolo County (LAFCo) will hold a Protest Hearing at the City of West Sacramento Civic Center, Council Chambers, 1110 West Capitol Avenue, West Sacramento, CA to consider the following agenda item:

### **Project Title:**

Davis Cemetery District Annexation (LAFCo № 915)

#### **Project Description:**

The annexation proposal was initiated by District Resolution on January 7, 2013. LAFCo approved the annexation proposal on March 28, 2013 as shown in LAFCo Resolution 2013-02 which is available for review at the LAFCo office or online at <a href="https://www.yololafco.org">www.yololafco.org</a>. The Attachment to the Resolution includes detailed maps of the annexation area. The annexation area expands the Davis Cemetery District's existing boundaries by 126,130 acres, annexing all the lands in its Sphere of Influence planning boundary north to County Road 27 and east to the Sacramento River including all of the land in the county south and east of that line including West Sacramento, Clarksburg and surrounding rural areas.

The existing cemetery in Davis has sufficient capacity to accommodate the new area and no new cemetery sites are proposed. The annexation allows residents in the subject area to have a public cemetery option for burial services. The annexation will not increase property taxes. The District is not seeking any property tax revenue for this subject territory and Cemetery burial costs will be handled by the District instituting a two-tiered fee system correlating to the tax rate areas zone of benefit.

#### Written Protest:

Written protests against this annexation may be filed by owners of land within the affected area **or** by registered voters in the affected area. Written protests may either be mailed to Yolo LAFCo, 625 Court Street, Suite 203, Woodland CA 95695, or delivered to the LAFCo Executive Officer at the Protest Hearing on April 25<sup>th</sup>. Each written protest must be filed no later than the conclusion of the hearing to be considered valid. The effect of protests received will be determined within 30 days following the hearing in accordance with Government Code Section 57075.
