

PERMIT CONDITIONS

1. The Applicant shall be responsible for routing equipment and insuring the least possible obstruction and inconvenience to the traveling public.
2. Movement of the equipment described herein will not be permitted during periods of excessive rain or fog except during an emergency. Movement of equipment will not be permitted on Saturdays, Sundays and legal holidays except as otherwise allowed on the attached permit. Equipment may be moved during periods of rain or fog provided that visibility is at least 1000 feet and provided, further, that pilot vehicles are furnished in advance and to the rear of equipment in the case of over legal width loads.
3. Pilot vehicles are furnished in advance of all loads with widths in excess of 12 feet, or over 100 feet in length. Pilot vehicles shall be furnished in advance of all loads with widths in excess of 10 feet in hilly terrain, roads where sight distances are limited and on roads where the total pavement width is 20 feet or less. Two pilot vehicles shall be furnished, one in advance and one following, all loads greater than 13 feet 11 inches in width, or over 120 feet in length.
4. The Applicant's attention is directed to the existence of other restricted roads which may not be listed herein or which may have had restrictions applied subsequent to the issuance of this permit, and to structures which may be too narrow or will not sustain applied loads or structures which may be stressed beyond capacity. It shall be the responsibility of the Applicant in planning routes under this permit to call the County's attention to such structures along a planned route, in advance of a move, in order that an investigation can be made by the Department of Public Works.
5. It is understood and agreed that the Applicant will be held responsible for any traffic accidents resulting from the movement of the equipment or vehicle shown on the attached permit as well as any damage to County roads, culverts, signs, bridges and other highway facilities. The Applicant shall indemnify and save harmless the County of Yolo and all its officers and employees from all suits or actions of every name, kind and description, brought for or on account of injuries or damages received or sustained by any person or persons, by or from the Applicant, his servants, or agents, in the movement of the herein described vehicle.
6. This permit shall be retained in the vehicle described on the attached permit when in transit and presented to law enforcement personnel or personnel from the Planning and Public Works Department of the County of Yolo upon demand.
7. The Applicant or his authorized representative shall notify the CHP Office in Woodland (530-662-4685) prior to the movement of loads or vehicles with widths in excess of 14'7". The Applicant or his authorized representative shall contact the California Highway Patrol Office in Sacramento (916-464-2090) to arrange for a CHP Escort prior to the movement of loads or vehicles with widths in excess of 15'0".
8. Weights or dimensions shall not exceed those indicated on the attached permit. For Annual Permits the loaded height limit is 14'0" (16'3" on a specific County approved route); loaded width limit is 15'0"; overall loaded length limit is 100'0" (105'0" for mobile homes on a specific County approved route).
