NOTICE OF RELEASE OF DRAFT AND PUBLIC HEARING TO CONSIDER ADOPTION OF A COMBINED MUNICIPAL SERVICE REVIEW AND SPHERE OF INFLUENCE STUDY FOR YOLO COUNTY WATER DISTRICTS

The Draft Combined Municipal Service Review Update and Sphere of Influence Study (MSR/SOI) for the Dunnigan Water District, the Yolo County Flood Control and Water Conservation District, and the Yolo-Zamora Water District will be available for public review beginning August 12, 2013, at the office of the Yolo LAFCo and online at www.yololafco.org. Written comments on the MSR Update and the SOI Study should be returned to the LAFCo office by September 6, 2013, either by mail at the address stated below or via e-mail to Yolo LAFCo Executive Officer Christine Crawford at lafco@yolocounty.org.

The Commission will receive an overview of the draft MSR/SOI and will consider recommendations for MSR and SOI determinations and related SOI updates for these agencies. The public hearing will include an overview of comments received and responses to those comments. Public comment will also be taken at the hearing. The Commission will be asked to adopt the MSR and SOI determinations and update the agencies' SOIs.
