- i) G. Moris will e-mail past ECAC letters on the subject to refresh everyone's memory.
- ii) J. Hulsman The big question might be what they will rezone your parcel. Theoretically, it is based on the minimum land you can live off of based on irrigation, etc. May not be the best strategy if they are trying to save farmland. Soil classifications would be better.
- iii) Public comment.
 - (1) AP vs current zoning same protections?
 - (2) AP previously allowed only 2 homes if both residents farmed. That requirement was later dropped.
- b) Letter in support CVV Ag Task Force
 - C. Havstad is in support of a letter. She likes the principals that the CVV Ag
 Task Force has presented in their letter and would be in support of including
 them in our letter.
 - ii) County asked CVV Ag Task Force to reduce the list to their top priorities. Maya Walker (CVV) explained that they have consolidated items and are updating the request.
 - iii) G. Moris recounted Eric's concerns with self certification and permanent ramifications of that. Maya clarified that this is just in the early stages and applies more to low risk activities.
 - iv) G. Moris believes density is a factor that should be considered.
 - v) C. Havstad supports Ag Task Force taking the lead in discussion on event centers. That sentiment could be included in the letter.
 - vi) Member of Public at the Board of Supervisors today, they recognized that the County is lacking a definition of an event center.
 - vii) It was suggested that the ECAC also weigh in on this in support of the defining process.
 - viii) J. Hulsman hesitant to endorse something that is not finalized.
 - ix) C. Fescenmeyer supports the "non-event" events like school trips to the farms
 - x) C. Havstad to start the draft, and send to G. Moris.
