Motor Vehicle Operation

- 35. No motor vehicle shall be driven across or upon any active runway, taxiway/apron where aircraft regularly operate, except by tenants and their invited guests, emergency vehicles, and those on official airport business.
- 36. Speed limit = 25 MPH within the confines of the airport, 15 miles per hour within 150 feet of any aircraft or building, and slower if safety requires.
- 37. Aircraft shall have the right-of-way at all times over all motor vehicles operating within the airport.
- 38. No person shall operate any vehicle or travel on the airport in any manner except on the roads, walks, paths, and areas designated for the particular means of travel. No obstruction shall be permitted on any road, walk, or path without the prior permission of the County.
- 39. Overnight camping or parking is prohibited except as authorized by the Yolo County Board of Supervisors.

Airport Rules for Tenants and Visitors



Summary of Requirements for Conducting Safe activities while on Airport Property.

Tenant & Visitor Safety

The rules in this document can be found in Yolo County Codes, Title 4, Chapter 5, Articles 1-10, Sections 4-5.501 through 4-5.1006

Fire Safety

- Passenger vehicles and trucks shall not be stored or operated inside hangars, except one passenger vehicle may be stored in a hangar when not occupied by the aircraft normally stored in that hangar.
- Power operated industrial vehicles used or stored within hangars shall be approved by the Fire Department and meet all OSHA standards
- No aircraft or other vehicles may be fueled or defueled within any hangar.
- Fuel shall not be stored within any hangar or other building not designed for the purpose, except fuel remaining in the fuel tanks of aircraft stored within the hangar.
- All equipment and storage facilities for fuel shall meet applicable FAA and Fire Department regulations and other applicable laws.
- Smoking is prohibited in hangars. "No smoking" signs shall be posted in all hangars.
- Smoking, matches or other ignition sources are prohibited within 50' or any aircraft while being fueled, a fuel island, flammable liquid container, or aircraft workshop;
- Cutting, welding, soldering, doping, and spray painting shall be conducted only in areas and buildings approved by the Fire Department
- Suitable fire extinguishers shall be provided and installed in all hangars as directed by the Fire Department.
- Fire extinguishers shall be kept fully charged at all times, and shall be inspected periodically by the Fire Department.
- Access to fire extinguishers shall be kept free and unobstructed at all times.
- 14. Each fixed base operator shall train employees in the use of portable fire extinguishers and in evacuation and relocating occupants in the event of a fire or other emergency.

- 15. All flammable materials, including oily wastes, rags, and similar combustibles shall be stored in metal containers equipped with self-closing doors and lids approved by the Fire Department.
- 16. Any flammable liquid, solid, gas, signal flare, or similar hazardous material stored inside a hangar shall be stored in areas, containers, and quantities specifically approved by the Fire Department.
- 17. All building and hangar floors shall be kept free and clear of oil, grease, and other flammable materials. No flammable substance shall be used to clean floors.
- Only nonflammable high flashpoint (100 deg. F or greater) shall be used during any cleaning process, including cleaning aircraft parts.
- Disposal of gasoline, oil, solvent, or other flammable waste products into any drain, manhole, open ditch, or other airport area not designated for such purpose shall be strictly prohibited.
- 20. Drip and collecting pans shall be used during any cleaning process and shall be emptied daily.
- All electrical wirings, fixtures and appliances shall be installed and maintained in accordance with current electrical code.
- 22. Anyone who becomes aware of any fire or smoldering combustion which is not confined within equipment designated for the purpose, and which constitutes a potential hazard to the premises or a person, shall report such fire or smolder to the Fire Department immediately.
- 23. All persons shall comply with all fire safety regulations established the Fire Department, the County, or any other government entity. Currently adopted NFPA standards apply. All persons using or occupying the Airport shall be familiar with those standards.

Littering

- 24. All persons using the airport shall place all rubbish, garbage, and other debris in appropriate containers.
- Operators performing routine maintenance on their own aircraft shall keep the area neat and uncluttered at all times.
- Washing shall not result in any discharge to groundwater.

Accident Reporting and Assistance

- Anyone involved in or witnessing an emergency at the Airport should immediately call the West Plainfield Fire Department or County Sheriff for emergency response.
- 28. Witnesses to any accident involving injury or damage to an aircraft shall promptly make a full report to Davis Flight Support, and the County Airport Manager. Certain accidents, including those involving hospitalization or over \$25,000 damage to aircraft are also reportable to the FAA.
- 29. Aircraft operators, owners, or their agents, or permittees of aircraft involved in any accident shall be responsible for, and shall cooperate and assist in, the prompt removal of damaged aircraft, parts, property, or debris resulting from such accident unless prohibited by the FAA, a County official or law enforcement officer.

Contracts and leases

- 30. Anyone wishing to operate a business of any kind shall first have a written lease or contract with the county, and any applicable business licenses.
- 31. The County shall charge reasonable fees and rents for use of the Airport and its facilities.

Financial Responsibility

- 32. All registered owners of aircraft regularly situated at the airport shall be financially responsible for bodily injury, death, and property damage in amounts specified by the County. Satisfactory evidence of financial responsibility shall be provided to the County
- 33. If the owner of an aircraft regularly situated at the airport fails or refuses to furnish the required evidence of financial responsibility within a reasonable time, he/she be prohibited from basing any aircraft at the airport.
- 34. All persons using the facilities of any airport located in the County shall be deemed to have agreed with the County to indemnify and save harmless the County, and its officers, agents, and employees, from any and all liability against the County arising from the use of the airport by such person.
