The purpose of this letter report is to provide the results of the cultural resources records search and literature review for the proposed 3,363-acre Dunnigan Specific Plan project in Yolo County, California. The Project Area is situated in Sections 9, 15-17, 20-22, 26-28, 33, and 34 of Township 12 N, Range 1 W of the Mount Diablo Base and Meridian, as depicted on the Dunnigan and Zamora, California 7.5' topographic quadrangle maps (Attachment A). ECORP Consulting, Inc. (ECORP) conducted a cultural resources records and literature search and map review for the Project Area. This analysis included: a review of cultural resource records and literature; an examination of cultural resource maps for the Project Area; and a sacred land file search by the California Native American Heritage Commission (NAHC). The purpose of this review is to provide you with preliminary information about the cultural resources sensitivity of the Project Area.

RECORDS SEARCH

Methods

The cultural resources records search was conducted by ECORP at the California Historical Resources Information System's Northwest Information Center, located at Sonoma State University (Attachment B). The purpose of the records search was to determine the extent of previous surveys within a 0.25-mile (400-meter) radius of the property, and whether previously documented prehistoric or historic archaeological sites, architectural resources, cultural landscapes, or ethnic resources exist within this area. Materials reviewed included survey reports, archaeological site records, historic maps, and listings of resources on the National Register of Historic Places (NRHP), California Register of Historical Resources (CRHR), California Points of Historical Interest, California Historical Landmarks, and National Historic Landmarks. ECORP also contacted the NAHC to request a search of its sacred land files for the presence of traditional cultural properties or sacred, religious, or otherwise important Native American resources (Attachment C).

Previous Research

Twelve previous cultural resource investigations have been conducted within 0.25 mile of the property, covering approximately five percent of the total area surrounding the property within the record search radius (Table 1). These studies revealed the presence of prehistoric sites, including lithic scatters and habitation sites, and historical sites, including rock walls and sites associated with historic ranching activities. The previous surveys were conducted between 1974 and 2003 and vary in size from less than one acre to 2,000 acres.

The results of the records search indicate that less than 5% of the Project Area has been previously surveyed for cultural resources by a professional archaeologist. Most of those surveys are more than 10 years old and were conducted under obsolete protocol, or both.

Records

The Office of Historic Preservation's Directory of Properties, Historic Property Data File (dated 5/27/2009) includes 14 resources within the Project Area (including the eight resources listed in Table 2). Five of the 14 resources appear eligible for the National Register, four resources are locally significant individually and as a district, two resources are individually eligible for local listing, one is determined ineligible for the National Register, one needs to be reevaluated for National Register significance, and one is a contributor to a district that is locally eligible (Table 3).

A review of *California Inventory of Historic Resources* (March 1976) indicated that there are no historic properties within the Project Area.

The National Register Information System (National Park Service 2009) similarly failed to reveal any significant properties within the Project Area.

A review of *California Historical Landmarks* (Office of Historic Preservation [OHP] 1996) listed the nearest landmark located in Woodland. The Office of Historic Preservation website (OHP 2009) was consulted on 31 August 2009 and failed to list any updated Historic Landmarks in the Project vicinity.

A review of *Historic Spots in California* (Kyle 2002) does not mention Dunnigan or any surrounding towns. The nearest town referenced is the town of Yolo, located along Cache Creek, 13 miles southeast of Dunnigan.

According to Gudde (1969), the town of Dunnigan was named after A. W. Dunnigan, the first Euroamerican to settle the land in 1853. By 1876, the Northern Railway reached the point of the town and a station was built.

Historic GLO land patent records on file with the BLM's General Land Office (BLM 2009) revealed that several people had owned the land within the Project Area as early as 1853 (Table 4).

ECORP mailed a letter to the Yolo County Historical Society on 16 September 2009, requesting information for the land surrounding and within the Project Area (Attachment D). To date, no responses have been received from the Yolo County Historical Society.

Map Review and Aerial Photographs

In addition, the following maps and aerial photographs were reviewed for information on the history of the Project Area, which might indicate the presence of historic-era resources:

• The 1872 GLO Plat map for Township 12 North, Range 1 West did not reveal any structures or settlements within the Project Area. The land directly east of the Project Area was indicated as "swamp and overflow land."

- A review of the historic 1907 USGS Dunnigan, CA (1:62,500) map revealed the Southern Pacific rail line running through the Project Area. The town of Dunnigan also appears on the map with several structures.
- Aerial photographs taken in 1937 reveal the railroad line going through the town of Dunnigan. Most of the Project Area surrounding the town had been converted to agriculture fields.
- The 1939 photorevised 1907 Dunnigan, CA (1:62,500) War Department Corps of Engineers map reveals the addition of agricultural lands north of the town of Dunnigan. The map also indicates Highway 99W running parallel to the railroad line through the entire Project Area.
- The 1941 USGS Dunnigan, CA (1:62,500) is similar to the 1907 version, except for the addition of orchards and agricultural lands directly north of the town of Dunnigan. A new highway labeled W99 running parallel to the Southern Pacific rail line was depicted on the map.
- The 1953 USGS Dunnigan, CA (7.5-minute) map is the same as previous years, with the exception of additional orchards northeast of the town of Dunnigan.
- Aerial photographs from 1957 show a northwest/southeast alignment east of the Project Area.
 The old part of Dunnigan appears to be the same as it is currently and the northern part of town
 appears to still be in agriculture production, but with few residences located on rectangular
 parcels.
- The 1973 photorevised 1953 Dunnigan CA (7.5-minute) map shows the addition of Interstate 5, located west of the town of Dunnigan.
- Aerial photographs from 1978 and 1987 reveal the addition of a second road/highway located west of the old part of town running parallel to the railroad tracks and old road. The photographs also show the area north and west of the old part of town as developed into rural/residential areas.

In summary, the current Project Area was converted to agricultural sometime between 1907 and 1937. The small town of Dunnigan directly east of the railroad tracks remained primarily the same size until sometime between 1941 and 1953, when the land to the north and west began separating into smaller parcels containing farming land and residences. Finally, a second highway (Interstate 5) was constructed sometime between 1957 and 1973. Interstate 5 replaced and eliminated Highway 99W in 1967 (gbcnet 2009). The span of Highway 99W along Dunnigan had not been eliminated, but had become a frontage road for Interstate 5.

Native American Resources

The Project Area falls within the ethnographic territory of the Hill Patwin. The *Handbook of North American Indians, Volume 8*, lists the closest Native American Village as *Imil.* The village is located approximately ten miles west of Dunnigan on the southern side of Cache Creek.

A search of the NAHC's sacred lands file failed to indicate the presence of Native American cultural resources on the property. The NAHC provided a list of Native American tribes and individuals that should be consulted during the cultural resources inventory for information on possible Traditional Cultural Properties or prehistoric sites that could be affected by the project.

CONCLUSIONS

Based on the results of the records search and literature review, the Dunnigan Specific Plan Project Area has not been adequately surveyed for cultural resources. The property is situated in an area that is considered moderately sensitive for prehistoric cultural resources and highly sensitive for historic-era cultural resources that may be identified during a field survey and inventory. The records search shows that several buildings have been evaluated for inclusion for the NRHP. The town itself was considered eligible for inclusion on the NRHP; however, further evaluation will be required to fully evaluate the historic buildings and structures within the town of Dunnigan.

RECOMMENDATIONS

Until the Project Area has been inventoried, the proposed project has the potential to cause a significant adverse effect or a significant impact on cultural resources. In accordance with applicable state and federal law, the property will need to be surveyed by archaeologists who meet the Secretary of the Interior's Professional Qualification Standards for prehistoric and historic archaeology. If cultural resources are identified either by the survey or during any ground disturbing activity, then they will need to be evaluated for eligibility for the CRHR and the NRHP. If standing structures are present, then this will include evaluation of potentially historic structures by an architectural historian. If determined eligible, then mitigation could consist of either avoidance by preserving them in open space or by carrying out data recovery efforts prior to project approval, implementation, or construction.

Until the CEQA lead agency and federal lead agency (if applicable) concur with the identification and evaluation of eligibility of cultural resources, including archaeological sites and standing structures, no ground-disturbing activity or structural demolition should occur.




FIGURE 1. Project Site and Vicinity




FIGURE 1. Project Site and Vicinity




FIGURE 1. Project Site and Vicinity
