Project Title: Yolo-Zamora Water District Dissolution (LAFCo No. 916)

## Project Description:

On October 28, 2013, the Yolo Local Agency Formation Commission (LAFCo) received a resolution of application from the Yolo-Zamora Water District (District) initiating proceedings to dissolve the district.

It is proposed to dissolve the District because since its formation in 1955 the District has never had an allocation of water to provide as a service for agricultural irrigation purposes, has not collected property tax revenue and has consequently suffered from financial and operational challenges.

The District is generally located in the northeast quadrant of the county along the I-5 Freeway, just southeast of the I-5/I-505 Freeway interchange. The District is approximately 32.39 square miles or 20,726 acres.


