- V. Approve Day Reporting Center Relocation Plan (\$150,000 requested from CCP fund balance contingency) (Motion: Sheriff Prieto, Asst. CEO Berger, Passes 7:0)
  - a. Costs will cover \$40-50K in improvements to the Probation Building for DRC operations,
  - b. Office improvements at the Bauer Building due to 2 new departments occupying the same office space (Environmental Health, DESS, and Probation) no more than \$40K,
  - c. And the necessary pivot of Probation's Alternative Sentencing Program to Planning and Public Works to delay their inevitable integration onto the Probation Campus in order to temporarily accommodate the DRC for 2-3 years costing \$20K for portable setup and \$18K per year for rent.
  - d. Anticipated costs of approximately \$150,000 for 2- 3 years
  - e. Alternative option, Yolo County Office of Education Building would have cost between \$1.5 and \$1.9 million for a 3 year solution to accomplish the same integrations
