Notice of Availability of Draft MSR/SOI and Public Hearing**

NOTICE IS HEREBY GIVEN that on **Thursday July 24, 2014 at 9:00 am**, or as soon thereafter as the matter may be heard, the Local Agency Formation Commission of Yolo County (LAFCo) will hold a Public Hearing at the Yolo County Board of Supervisors Chambers, 625 Court Street, Room 206, Woodland, CA to consider adoption of a:

**MUNICIPAL SERVICE REVIEW (MSR) AND SPHERE OF INFLUENCE (SOI) STUDY FOR THE CACHEVILLE COMMUNITY SERVICES DISTRICT**

The Draft Municipal Service Review (MSR) for the Cacheville Community Services District (CSD) **will be available for public review beginning June 12, 2014**, at the office of the Yolo LAFCo and online at [www.yololafco.org](http://www.yololafco.org). On the basis of the Municipal Service Review, Staff has reviewed the agency's Sphere of Influence (SOI) and recommends that a SOI Update is not necessary in accordance with Government Code Section 56425(g). Therefore, no change to the agency's SOI is recommended. Written comments on the MSR should be returned to the LAFCo office by **July 10, 2014**, either by mail at the address stated below or via e-mail to Yolo LAFCo Executive Officer Christine Crawford at [lafco@yolocounty.org](mailto:lafco@yolocounty.org).

The intent of the Municipal Service Review is to review the services being provided by the CSD. The Commission will receive an overview of the draft MSR and will consider recommendations for MSR determinations for the CSD. The public hearing will include an overview of comments received and responses to those comments. Public comment will also be taken at the hearing. The Commission will be asked to adopt the MSR determinations.
