1. Call to Order and Introductions – The June 10, 2014 meeting of the Community Corrections Partnership (CCP) was called to order at 1:34 pm. Chief Cardall introduced our new Juvenile Detention Facility, Superintendent, Mr. Patrick Turturici. Attendee introductions were made.

 4. Updates -
 - a. CAO and Probation memo response to Board request regarding questions from Realignment Outreach Meeting in April (Attachment B).
Chief Cardall sent his response to the Board of Supervisors regarding the April Realignment Outreach meeting. Chief thanked Patrick Blacklock for delivering the response to the Board.
 5. Inclusion of Community Corrections Partnership Mission and 5 Goals with each CCP agenda going forward -
Chief Cardall states the mission and each goal will be placed on all CCP agendas.

6. Crime and Justice Institute (CJI) Strategic Planning Updates – Zach Dal Pra
 - a. CJI Assessability Report (Attachment C) -
Mr. Dal Pra gave the Assessability Project update. All items contained in the report must be implemented by September 2016. Project will require seed funding. Mr. Dal Pra will be meeting with Mr. Ted Martinez of CJI to start implementing strategies.
 - b. CCP Strategic Planning Workgroup Update –
Zach very pleased with the Mission and Goals from the last planning session workgroup. He will be meeting with the newly formed workgroup tomorrow to start working on the objectives.
 - c. JRI Update –
Zach went over the importance of accountability and evaluation. You must be able to provide value to the outcome of the programs. Zach inquired as to any items that are not complete. All items have been implemented and require no follow-up.

8. Board of State and Community Corrections(BSCC) Draft State Definition of Recidivism -

Discussed BSCC proposed rule making regarding definition of recidivism.

Probation staff recommended increase to the 4th and Hope and Cache Creek Lodge contracts along with extending the CommuniCare contract. Some voting member's inquired if the contracts can be modified due to funding reductions. Chief Cardall confirmed we can modify the contracts.
