- 7) Action Items
  - a) Zoning Code update
    - i) G. Moris summarized latest changes.
    - Antonia Planning Commission reviewed updates and they are targeted for Board of Supervisors on July 15<sup>th</sup>. Should be another staff report from Planning.
    - iii) Propose changing text on page 89 section (2). Why should special event facilities be allowed by right and then say at the discretion of the Planning Director it could be a site plan or minor use permit. If the intent is by right, then take out second sentence. If they want to review, then delete the by right and let them be minor use permits. Otherwise, this is asking for trouble and a repeat of the recent controversy where investments are made already.
    - iv) Requiring a minimum number of acres for an event facility is a good start to address density concerns; but proximity to other residences is still a concern.
    - v) Hog farms definition seems strange and could be clarified better.
    - vi) Antonia to follow up to see if the Board of Supervisors adoption vote will be continued.
    - vii) No letter needed, just advise Eric to review our minutes for these comments.
