eTRAKiT User Registration Application

TERMS AND CONDITIONS:

The eTRAKiT system is an optional Internet service provided by the County of Yolo, which replaces our
fax-in permit program. In consideration of being authorized to use eTRAKiT,
(hereinafter referred to as the "licensee")

understands and agrees to the following terms and conditions:

- Only the licensee may obtain any type of building permit through eTRAKiT. The licensee will keep confidential and shall take all necessary steps to insure that any passwords or PINs used to access eTRAKiT shall only be used by licensee and licensee shall be fully responsible for any use of the eTRAKiT system by persons using any password or PIN issued to licensee.
- 2. All work authorized by any permit must comply with all applicable ordinances and codes adopted by the County of Yolo.
- 3. All work authorized by permit is subject to inspection. Required inspections can be scheduled by calling the Building Inspection Division at (530) 666-8775 or via the internet.
- 4. Permits shall automatically EXPIRE, and become void if work has not started within 180 days from the issuance date, or if the work starts and then stops for a period of six months. One extension of up to six months may be granted if requested in writing, along with applicable fees. All work authorized by this permit must be completed within 1 year from the issuance date
- 5. "Simple Permits" are permits that do not require any discretionary approvals or plan review by the County. If, subsequent to the issuance of a Simple Permit, the Building Official determines that plans or other review are required for the work undertaken, the permit may be suspended or revoked until such time as proper reviews and approvals are obtained.
- 6. The issuance of a Simple Permit shall not serve to legalize other unauthorized construction, improper occupancies, additional dwelling units, or unauthorized land uses not otherwise legally established. All Simple Permits are subject to review and approval by the County of Yolo Building Inspection Division.
- 7. Work shall not commence until the licensee is in receipt of an issued building permit.
- 8. The licensee must be properly licensed by the State Contractors Board to perform all work for which licensee obtains permits. All permits will be verified upon issuance. Plumbing, mechanical, electrical and roofing permits issued to B (General) License contractors will be void and ineligible for refund.

- 9. The licensee hereby certifies that all information provided herein are correct and that all information that licensee, or licensee's authorized agents, will provide through eTRAKiT will be correct.
- 10. Licensee shall abide by all the terms listed in the declaration on the building permit. Licensee or licensee's authorized agents must print, sign and post the permit and inspection record list at the job site.
- 11. Only the "Descriptions of Work" supplied by the County of Yolo within this application package shall be used to obtain permits through eTRAKiT. All permits with unauthorized description are subject to revocation.
- 12. The licensee's ability to continue using eTRAKiT shall be revoked if the license fails to adhere to any of the above noted terms or any County Codes or ordinances, or any State or Federal laws or regulations.
- 13. "Total fees due" refer to Building Inspection Division fees only. All other fees (i.e. public works, environmental health and fire department, school, inclusionary housing, etc.) are paid separately.

Using eTRAKiT:

- To initiate the permit application in eTRAKiT, a valid address must be selected into eTRAKiT. If the licensee does not find the valid address, the licensee must contact the Building Inspection Division to correct discrepancies or assign an address.
- Upon renewal of the licensee's State Contractor's License and/or County of Yolo Business License, the licensee must contact the Building Inspection Division to update your file. The licensee cannot obtain web permits if the licensee's State Contractor License or County of Yolo Business License does not appear to be current in the County's tracking system.
- eTRAKiT is only valid for those certain types of eligible Simple Permits listed below. When
 obtaining a permit through eTRAKiT, the licensee must use only the descriptions of work
 provided in this document and only obtain the type of permit authorized by the licensee's State
 Contractor's License classification.
