 Call to Order and Introductions – The September 08, 2014 meeting of the Community Corrections Partnership (CCP) was called to order at 1:37 pm.

Roundtable discussion on Legislative Update, FY 13/14 Fund Balance, CCP Budget items along with the District Attorney and Public Defender's items. Mr. Blacklock gave an example of base and growth formula coupled with the possibility of looking at a multi-year (3 plus) plan. Mr. Blacklock suggested meeting prior to the BoS meeting on 9/23/14 and outlining a balanced budget. Chief Cardall went over some Probation line items where some cuts could be made. Overall, they totaled roughly \$150K. Mr. Reisig suggested the possibly of requesting some general fund dollars to assist with the CCP shortfall. Chief states we are still looking at a \$600K shortfall. Ms. Cook mentioned we need to be attentive with having our funding plan match our strategic plan. Mr. Landry states we need to make sure we review our revenue vs. expenditures and work on a long term multi-year plan as suggested by Patrick. All voting members were in agreement of meeting on September 15th beginning at 8:30 a.m. at the Atrium Training Room. Lisa will send out the invitation.

Chief Cardall went over the letter from the Board of State and Community Corrections that was sent to the Chief Probation Officer of California regarding the Community Recidivism Reduction Grant. Chief suggested we use our \$50K allocation for for Transitional Housing/Emergency Shelter Services. All voting members were in agreement of diving the \$50K among five (5) treatment providers.
