(Woodland, CA) – The Yolo County Department of Employment & Social Services, in partnership with the City of West Sacramento, the West Sacramento Chamber of Commerce and the Yolo County Workforce Investment Board, will be holding a job fair on Wednesday, October 29, 11:00 a.m. to 2:00 p.m. at the City of West Sacramento Galleria, located at 1110 West Capitol Avenue in West Sacramento.
