Chief Cardall announced the Board of Supervisors approved our Crime and Justice Institute's Yolo County Strategic Plan in October. Chief thanked the Board for approval of the CJI Strategic Plan. Chief Cardall and CAO Blacklock will meet to review the unfunded request and County funding options. Chief Cardall will be reporting to the Board of Supervisors future goal accomplishments.

Supervisor Provenza suggested we look at both our expenditures and revenue as outlined in our recently approved plan. Nate Palmer went over how each of the leads was outlined in the CCP Strategic Planning Matrix. As a group we went over each goal one at a time and assigned lead(s) to each task. Chief Cardall inquired as to how we want to complete and

report in on our assigned tasks. All voting members agreed Nate Palmer will check in with all leads on a quarterly basis prior to our regularly scheduled monthly meeting.

Ryan provided updated revenue projections of available funding for the CCP. The new unanticipated revenue will go into CCP fund balance if it is not allocated by the CCP.

7. Request for Annual Funding Support of Annual Courts Portal Fee (\$14K Annually For All Members) – Voting Members

Chief Cardall explained the probation department covered the initial start-up fees of \$44K.
