Health and Human Services: Joan Planell, who currently serves as the Department Head for DESS,
was selected as the director for the Health and Human Services Agency. Joan will be transitioning to
her new role in April. The next steps are working to completing her executive team.

- **Healthy Yolo:** Healthy Yolo has developed workgroups to work on the Community Health Improvement Plan. The priority areas are mental health, chronic disease prevention, and health issues related to aging. If you are interested in joining a workgroup, please let Emily Vaden know.
- **Tobacco Program:** The Tobacco program will be moving forward on their policy work, which includes no e-cigarettes in public places in the unincorporated areas of the County, which a letter of support was provided for.

- **Perinatal Mental Health Collaborative:** Just celebrated their one year birthday. Anna Sutton shared a draft infographic and will send it out once it is finalized.

As part of the awareness campaign for May, which is Maternal Mental Health month, the Collaborative has made a traveling blue dot. The Blue Dot is the universal symbol for postpartum depression. Right now, the Dot is being used as a prop for photos and is going around to each agency that is part of the collaborative to show their support of maternal mental health.  - Ashley Logins-Miller: Shared that the Public Health and Wellness Fair is April 8th. The flyer can be found HERE.


