Reason for Recommended Action/Background

INVESTMENT PORTFOLIO

The county treasury investment portfolio is summarized in <u>Att. A - Investment Summary</u>. It includes county funds and deposits from special districts and school districts totaling \$444 million as of March 31, 2015. The portfolio consisted of 2% (\$7 million) in cash at bank; 37% (\$166 million) in short-term investments in government investment pools such as the Local Agency Investment Fund (LAIF) and the California Asset Management Program (CAMP); 61% (\$271 million) in an investment pool that is actively managed by a professional investment advisor, PFM Asset Management, LLP (PFM). These investments consist mostly of fixed income securities as authorized by code, such as U.S. Treasuries; securities issued by federal agencies such as FNMA (Fannie Mae), FHLMC (Freddie Mac) and Federal Home Loan Bank; corporate notes; commercial papers; and certificates of deposit. The detail of investments is shown in Att. B - PFM Statements.

In their quarterly investment review for the 1st quarter (<u>Att. C - Investment Performance 1Q15</u>), PFM noted that interest rates remain volatile and that the Fed is unlikely to raise rates soon since inflation is still below target. In the meantime, the labor market continues to strengthen (with unenmployment rate at 5.5%) and consumers continue to spend, driving economic growth. According to approved strategy, PFM continues moving asset to the long-term to achieve the new 30% short-term and 70% long-term target. PFM reported that the portfolio complies with codes and investment policy, and is well diversified. In the first quarter of 2015 the portfolio achieved an annualized return of 1.96%, versus benchmark of 1.07%.

CASH BALANCES

The chart (Att. D - Cash Chart) depicts the cash balances of the three major operating funds of the County, and their combined balance. On March 31, 2015 this balance was \$52.2million, down \$7.6 million from the prior month due to normal operating expenditures. We maintained a Reverse Repo borrowing transaction that was repaid 4/24/15; we are monitoring cash balance and will likely renew the borrowing in the fall of 2015. The combination of the County's proactive budgetary management and the economic recovery is evidenced by the positive growth of balances subsequent to September 2010.

The Yolo County investment pool is in compliance with the Yolo County Investment Policy. Our analysis indicates that the investment holdings in the Yolo County Investment Pool are of proper amount and duration to meet the estimated cash flow requirements of the county and all pool participants for the next six months, barring substantial cash payment deferrals from the State government or other

Other agencies having deposits in the pool include: school districts, special districts, cities, Sacramento-Yolo Mosquito District and YCPARMIA. - These securities are in the custody of Wells Fargo Bank Trust Services, not the County Treasurer. Market value is determined by PFM Asset Management LLC, and is not materially different from those reported by Wells Fargo Bank Trust Services.
- In July 2002, the Board of Supervisors approved the investment of proceeds from the securitization of Tobacco Settlment Receipts in a Capital account and an Endowment Account. The Capital Account was used to finance part of the cost of the Bauer Building and the cost of the Energy Conservation Project and has been closed. The Endowment Account (shown above) is in the custody of a trustee and generates semi-annual deallocations that fund the Pomona Fund and are appropriated annually.
- In April 2006, Yolo County received \$9,139,612 from participation in the sale of Series 2006 Tobacco Securitization Program. These funds are earmarked for capital projects in accordance with bond documents. In August 2009 the Board approved the purchase of the Bauer Building using \$9.7 million of the 2006 Capital Account funds. This account has been closed
- These funds are invested in accordance with bond documents and as authorized by the Yolo County Investment Policy.

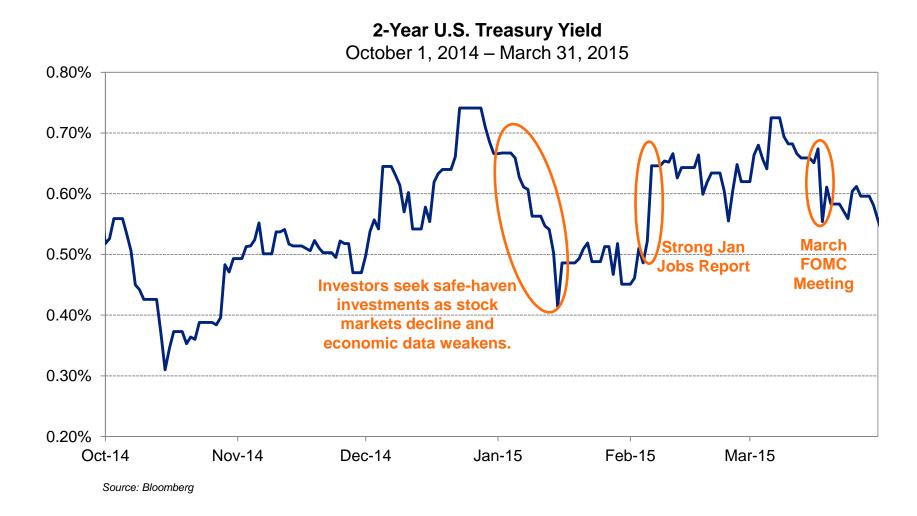

- Disappointing economic data and statements from the Federal Open Market Committee indicating a longer timeline to the first rate hike caused yields to fall in January and March.
- Positive economic data pulled rates up in February.

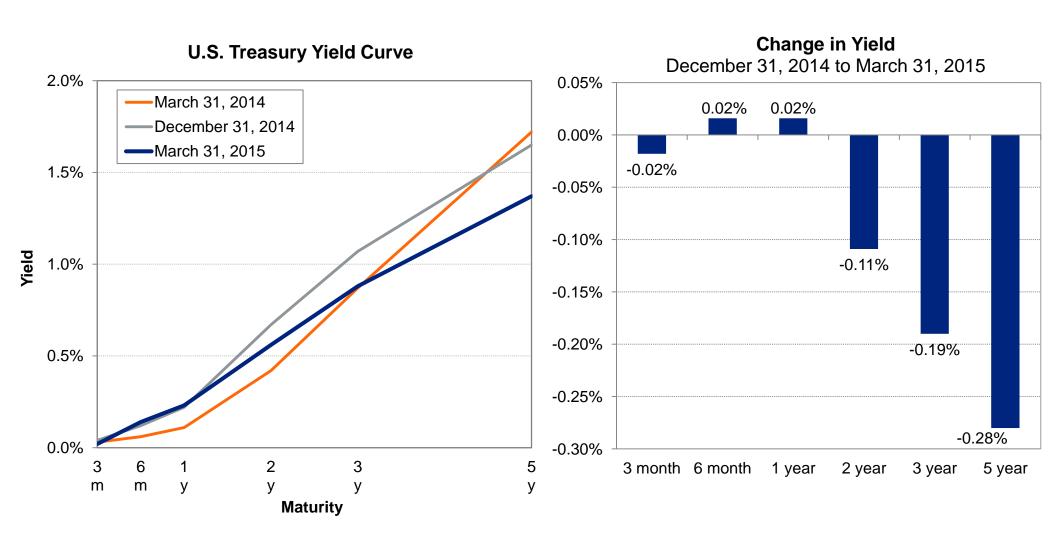
- Economic growth has moderated somewhat...labor market conditions have improved further, with strong job gains and a lower unemployment rate...indicators suggest that underutilization of labor resources continues to diminish.
- Inflation has declined further below the Committee's longer-run objective, largely reflecting declines in energy prices...inflation is anticipated to remain near its recent low level in the near term, but the Committee expects inflation to rise gradually toward 2%...as the labor market improves further and the transitory effects of lower energy prices and other factors dissipate.
- The current 0 0.25% target range for the federal funds rate remains appropriate ... Committee anticipates that it will be appropriate to raise the target range for the federal funds rate when it has seen further improvements in the labor market and is reasonably confident that inflation will move back to its 2% objective over the medium term.
- This change in the forward guidance does not indicate that the Committee has decided on the timing of the initial increase in the target range.

The yield curve flattened over the quarter as rates continued to see downward pressure.

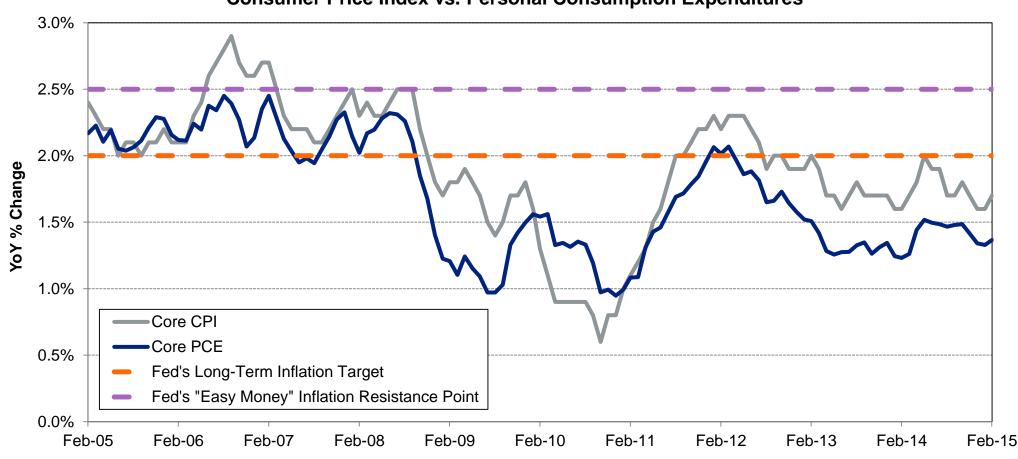


Inflation Remains Lower than Fed Target

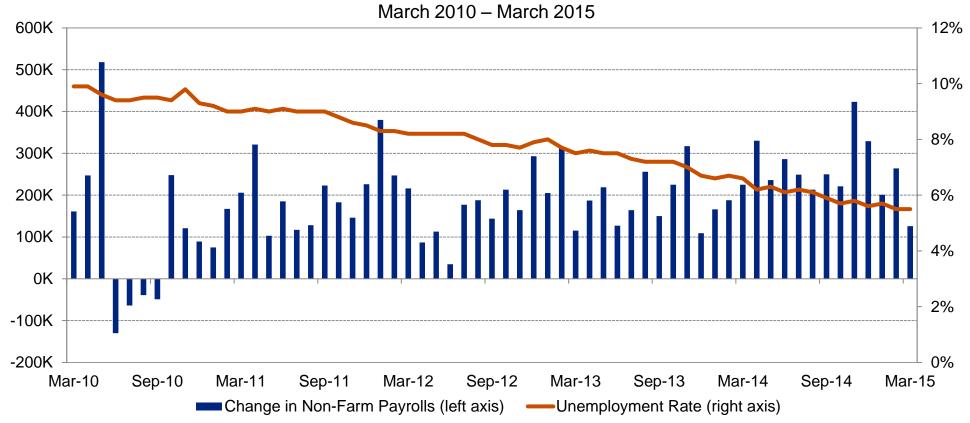
Inflation Measures: Consumer Price Index vs. Personal Consumption Expenditures



Labor Market Continues to Strengthen

- The U.S. Labor market added 591,000 jobs during the first quarter of 2015. The March job growth of 126,000 broke a
 twelve-month streak of monthly job growth over 200,000.
- The unemployment rate moved down 0.1% from 5.6% to 5.5%. The U-6 unemployment rate, commonly called the underemployment rate, declined from 11.2% to 10.9%.

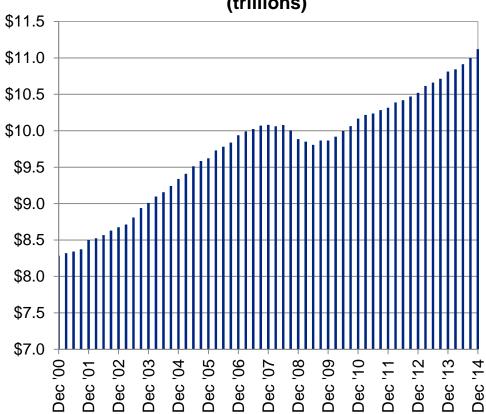
Consumers Continue to Support Growth

- Recent GDP readings have portrayed a significant contribution from the consumer sector. As Consumer Confidence
 has rebounded from its depths during the recession, so has consumer spending.
- Consumer behavior offers a vital indication on the general direction of economic growth as Consumer Spending accounts for approximately 63% of overall GDP growth.

First Quarter 2015 Recap

- As incoming economic data and FOMC statements seemed to suggest that the yield curve may be "lower for longer," we gradually extended the portfolio's duration to capture additional value and yield along the yield curve.
- We invested an additional \$16.7 million on longer-term securities to continue the transition of the investment strategy from 50% short-term/50% long-term to 30% short-term/70% long-term based on the cash flow analysis we have worked with the County on over the last few quarters.
- We continued to emphasize credit-related securities, an emphasis that was supported by strong corporate balance sheets, robust new corporate sector issuance throughout the quarter, and an earnings season that largely met expectations.
- Federal Agency yield spreads fluctuated throughout the quarter as they were unable to keep pace with the volatility experienced by their U.S. Treasury counterparts.
 - Spreads widened when Treasuries rallied and narrowed when Treasuries sold off.
 - We were able to capitalize on this yield spread relationship by adding exposure to the sector when spreads were at attractive levels.
 - Additionally, we found value in a callable Agency, specifically one with a one-time callable structure.

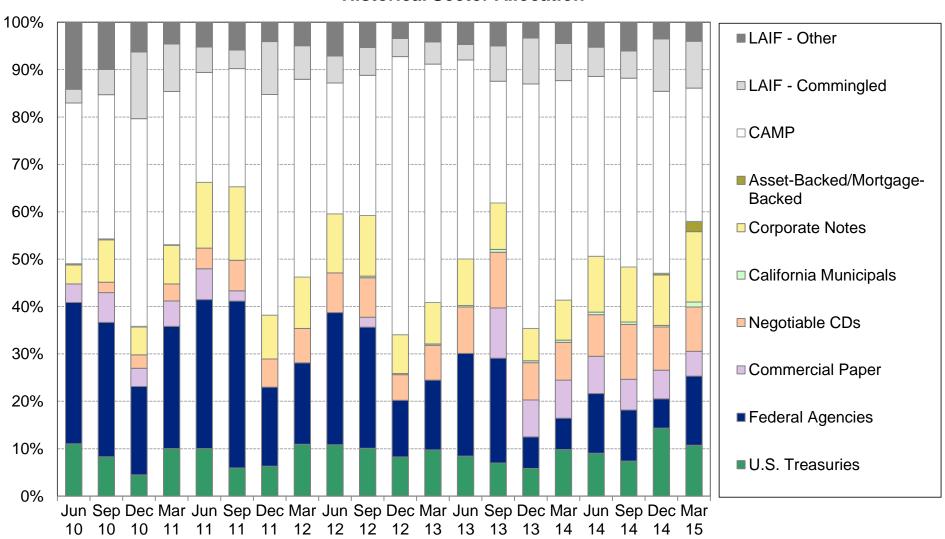

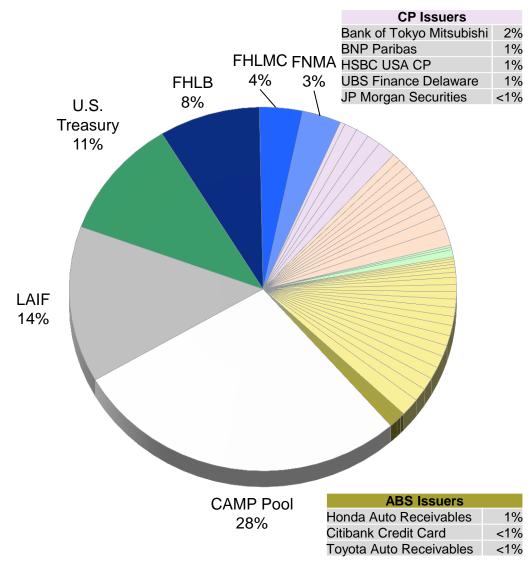
Added Value Through Sector Allocation

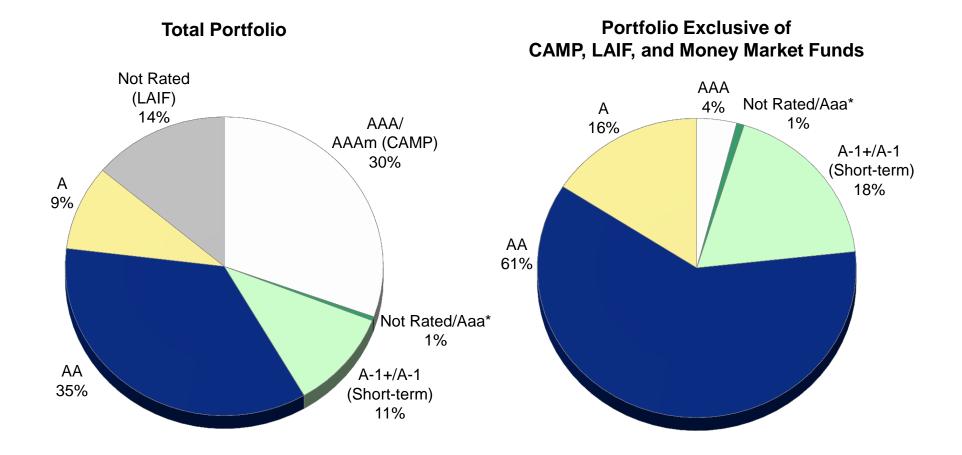

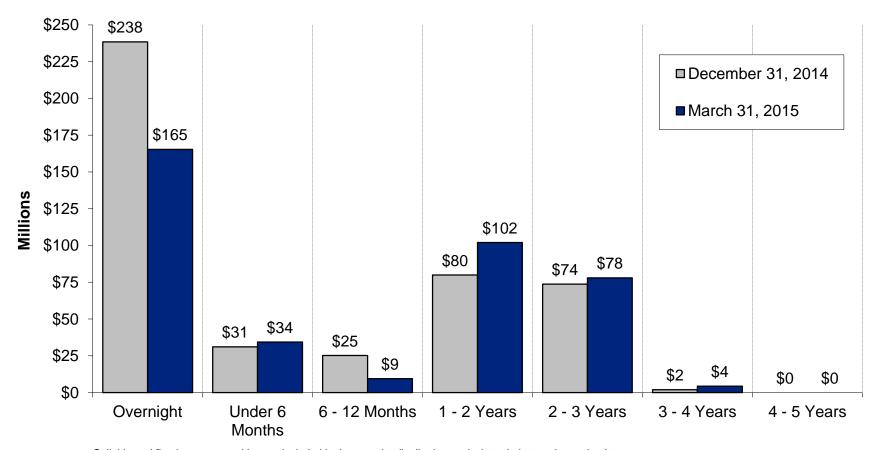

Portfolio Maturity Distribution

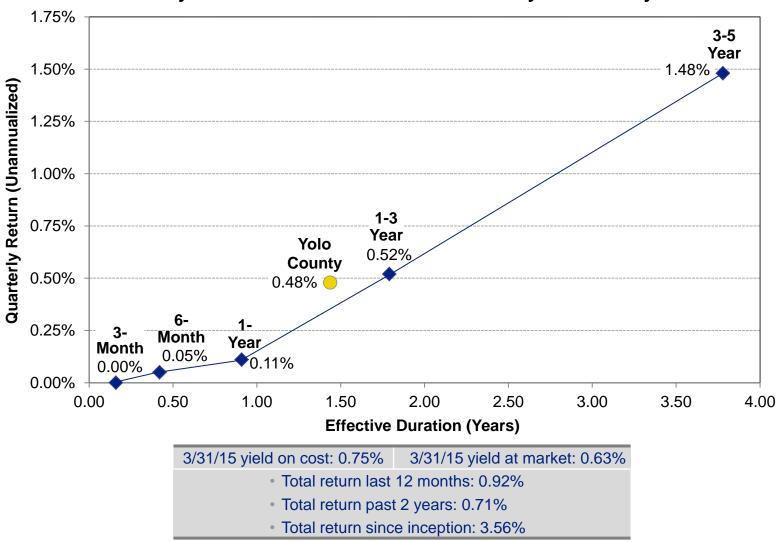

Yolo County and Various Bank of America Merrill Lynch Treasury Indices

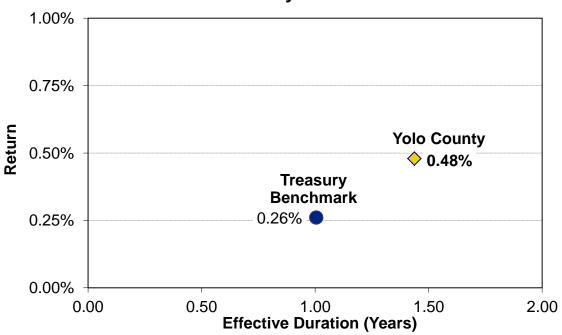

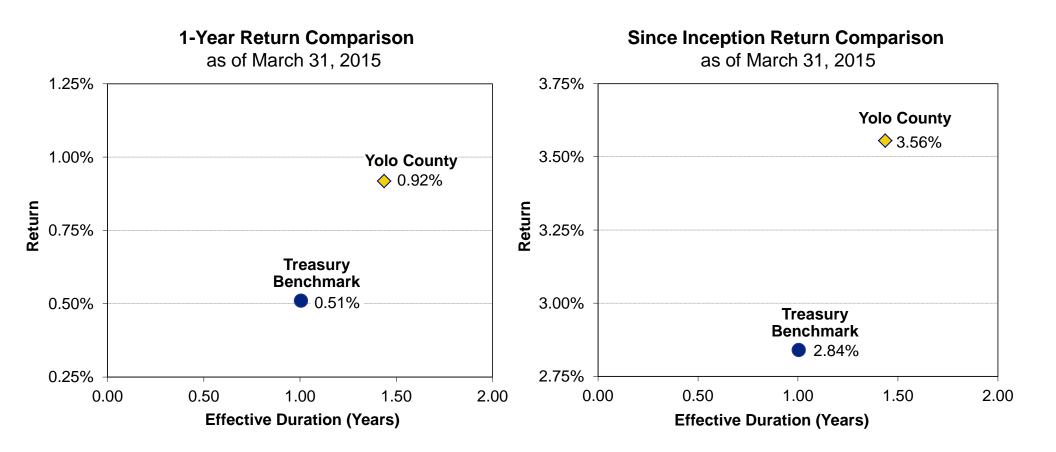

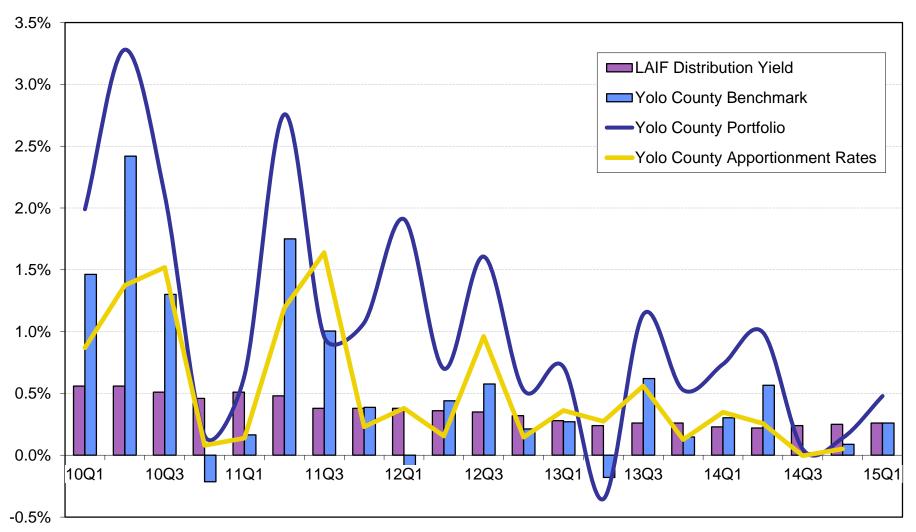
Portfolio Has Strong Long-Term Returns

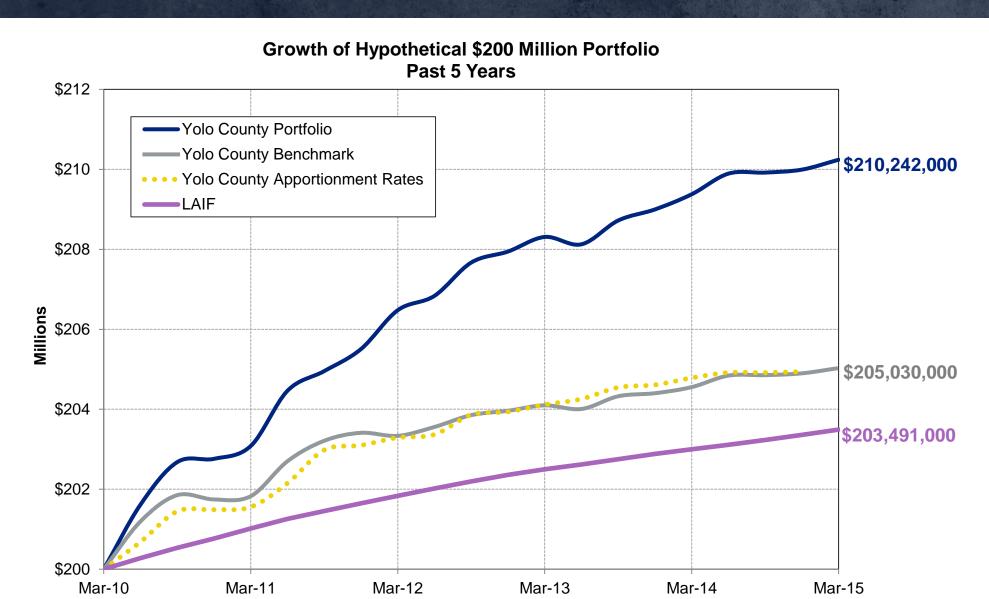

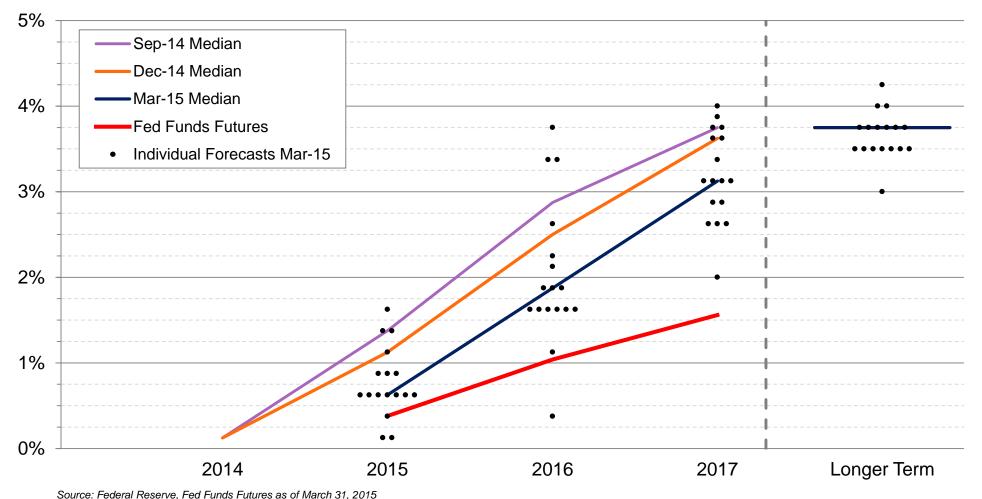
Current Strategy

- The U.S. economy should continue to gradually improve in the second quarter, supported by progressing fundamentals, a strengthening labor market, and continued monetary policy support.
- We expect that rates will remain in their current range in the coming months as stubbornly low inflation continues to undershoot the Fed's target range.
 - With this expectation, we will maintain a portfolio duration closer to the benchmark in an effort to maximize investment income.
- Volatility is expected to continue throughout the quarter. In a potentially turbulent market environment, we will look for
 opportunities to add duration when rates are elevated and remain patient when rates are restrained.
- We will continue the transition into longer-term investments and will switch to the 30% 3-Month Treasury/70% 1-3 year Treasury benchmark composition for the second quarter.
- Our focus will continue to be on high-quality security selection, opportunities in non-government sectors, and yield curve placement in our efforts to add value for the County.

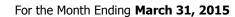

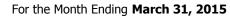
