5. Presentation by Yolo County Sheriff's Department Statistics – Mashan Wolfe

Ms. Wolfe distributed copies of the statistics to each member, as well as presented a power point demonstration. She went over in detail the following:

6. Presentation: Adverse Childhood Experiences (ACEs) Presentation – Jill Cook

Ms. Cook introduced Ms. Jane Stevens, Founder of the Adverse Childhood Experiences program. Ms. Stevens gave an overview of the program from its inception.

Adverse childhood experiences (ACEs) are stressful or traumatic experiences, including abuse, neglect and a range of household dysfunction such as witnessing domestic violence, or growing up with substance abuse, mental illness, parental discord, or crime in the home. ACEs are strongly related to development and prevalence of a wide range of health problems, including substance abuse, throughout the lifespan. When children are exposed to chronic stressful events, neurodevelopment can be disrupted. Disruption in early development of the nervous system may impede a child's ability to cope with negative or disruptive emotions and contribute to emotional and cognitive impairment. Over time, and often during adolescence, the child adopts coping mechanisms, such as substance use. Eventually, this contributes to disease, disability and social problems, as well as premature mortality.

Ms. Karleen Jakowski of Communicate explained the Yolo County Trauma Informed System of Care. Discussion

Chief Cardall thanked both ladies for the excellent presentations.
