#### 1. Approve Meeting Minutes

#### 2. Member/Jurisdiction Updates

#### City of Woodland - Roberta Childers

• Staff – Interviews conducted for open positions, but process is not yet complete

#### City of Davis - Jacques Franco/Jennifer Gilbert

- City Council approved the 1<sup>st</sup> reading of the new organics ordinance, 2<sup>nd</sup> reading set for May
  - Organic waste (food scraps and yard waste) collection set to begin in 2016.
- A series of "eco-classes" coming in May, topics include reducing toxins and composting.

#### **Environmental –** Larry Fisher

• Larry attended a workshop on managing "grey water" in the landscape and offered to share reference materials with those who were interested.

#### Yolo County – Marissa Juhler

- Free confidential paper shredding event at the Landfill on Friday, April 24<sup>th</sup>, from 10am to 2pm
  - Residents from all jurisdictions are welcome to attend
- Clarksburg Recycling Event, Saturday, April 25<sup>th</sup>, 9am to 1pm
  - Residents from all jurisdictions are welcome to attend
  - Accepting tires, paint, ag plastics, E-waste, and used clothing
- BOE Press event scheduled for Wednesday, May 20<sup>th</sup>
  - 5 truckloads of confiscated tobacco will be taken to the active face for destruction.
- Mattress Recycler (St. Vincent DePaul) is up and running in Woodland.
  - o Union/staffing issues are being addressed at the landfill before transport begins.
- Thanks to DWR for implementing new green waste services in North Davis Meadows.

#### Public/Schools - Dorothy Peterson

- 2 X 2 meeting with the city and school district to discuss uniformity in community outreach
  - Example: children are taught composting/recycling in school but at the neighboring city park separate waste and recycling cans are not available.
- Annual Tour de Cluck is coming in May. Vendors can apply to be a "Crower on the Green"

#### 3. MAC (Meeting of Area Coordinators) Update - Marissa Juhler

- CA state bottle/can funds will be funneled to the Sacramento Conservation Corp who will provide recycling services at the next Yolo County Fair this summer in Woodland.
- Saturday, May 16<sup>th</sup> the next Yolo County Filter Exchange Event

#### 4. California Product Stewardship Council (CPSC) – Linda Sinderson

- Extended Producer Responsibility legislation is now in place for paint and mattresses
- New language in AB45 mandates curbside HHW pick-up be paid for by local government
- CPSC is working to defeat AB 45 and asking for our support
  - Letters of opposition already submitted by at least 28 cities and counties
  - Costly responsibility of HHW disposal should be put on the producer

#### 5. 2015-16 IWM Division Draft Budget – Linda Sinderson

- Discussion covering the draft budget going to the Board in June
- Discussion regarding changes in proposed Master Fee Schedule, going to the Board May 5<sup>th</sup>
- Linda will email a copy of the draft budget and summary of fee changes to WAC members

#### 6. Organics and CDI Facility Update - Marissa Juhler

- Transition to new contractor is going well; Zanker Recycling is now operating the facility
- Operation as a transfer facility for food waste by January 2016 to comply with AB1826
  - Harvest Power in Lathrop will take food waste and other compostable materials
  - CalRecycle's official definition of food waste as it relates to Yolo County
- Abel Pereira with Zanker answered specific questions acceptability questions
- A tour will be set up in May or June for WAC members to see the CDI/GW facility on site.

#### 7. 2015 Proposed Waste & Recycling Legislation – Marissa Juhler & Linda Sinderson

- AB 45 Local funding of curbside HHW pick-up.
  - o Supporting extended producer responsibility, expect letters of opposition to this bill.
- Bulbs & batteries Efforts in the right direction, however programs are not sustainable.
- Recent committee meetings brought changes to bills of interest within the last week.
  - Updates to come next meeting.
