2015 YOLO COUNTY HOMELESS YOUTH POINT IN TIME COUNT


The Homeless Youth Point in Time (PIT) Count identifies and gathers information from unaccompanied youth who are homeless or unstably housed. Unaccompanied youth are 14-24 years old who do not live with or are not accompanied by anyone over 25 years old, including a parent, relative, spouse or partner. The Youth Count occurs every two years concurrently with the General Homeless PIT Count for adults by the local Continuum of Care (HPAC) and is mandated by the United States Department of Housing and Urban Development (HUD).


The Counts are based on where an individual slept on a specified night; this year participants were asked about their sleeping situation on the night of Monday, January 26th. HUD allows information to be collected over a seven day time frame and the Yolo County Youth Count surveyed and held activities throughout the week. Activities included youth focused street canvassing and magnet events throughout the County. Major partners in the Yolo County Homeless Youth PIT Count included:


This year, the Youth Count was more robust due to a \$12,000 grant from We Count, California! secured by the County Homeless Coordinator and HPAC. The funds allowed surveyors to use tablets as well as provide gift cards as incentives to participate in the survey. As a result of the grant and efforts of the Homeless Youth PIT Count Working Group, 49 homeless or unstably housed unaccompanied youth were identified.

Previous counts have sought to identify unaccompanied youth but specific methods were not used, resulting in little to no data. In 2011, one unaccompanied youth was identified while none were identified in 2013. Contrasting those results with this year's demonstrates the need to employ special methods to obtain more accurate data on homeless youth in our community. This document shows the results from 42 unaccompanied homeless or unstably housed youth surveyed during the 2015 Homeless Youth PIT Count.











Chronically Homeless *









Other reasons include:

- -Have no parents and no job


DEMOGRAPHIC INFORMATION & PERSONAL HISTORY




